### **Chairman's Statement**

# 主席報告



Dear Shareholders,

On behalf of the board ("Board") of directors ("Directors") of SIM Technology Group Limited ("Company"), I am presenting the annual results of the Company and its subsidiaries (collectively referred to as the "Group") for the year ended 31 December 2017 ("Year").

For the Year, the Group achieved a profit attributable to owners of the Company of HK\$111.7 million (2016: HK\$77.3 million). The basic earnings per share was HK4.36 cents (2016: HK3.02 cents).

### 致各股東:

本人謹代表晨訊科技集團有限公司(「本公司」) 董事(「董事」)會(「董事會」)提呈本公司及其附屬公司(統稱「本集團」)截至二零一七年十二月三十一日止年度(「本年度」)之全年業績報告。

本年度,本集團錄得本公司擁有人應佔溢利為 111,700,000港元(二零一六年:77,300,000 港元)。本年度每股基本盈利為4.36港仙(二零 一六年:3.02港仙)。



### **FINAL DIVIDEND**

The Board proposed to recommend a final dividend of HK1.6 cents per ordinary share to shareholders of the Company ("Shareholders") for the Year. Subject to the approval of the Shareholders at the forthcoming annual general meeting, the proposed final dividend will be paid on or about Thursday, 28 June 2018 to Shareholders whose names appear on the register of members of the Company on Friday, 15 June 2018. Based on 2,559,546,300 ordinary shares of the Company in issue as at the date of this report, the total dividend will amount to approximately HK\$41.0 million.

### **BUSINESS REVIEW**

The Group's business transformation has started to bear fruit, thanks to vigorous efforts it has undertaken in the past years. In 2017, affected by unfavorable factors such as the challenging global economic environment, large exchange rate fluctuations and intensifying market competition, nonetheless, the Group achieved revenue of HK\$3,258.5 million, representing an increase of 19.6% when compared with last year. Gross profit decreased by 1.6% year-on-year to HK\$395.2 million. These results were attributable to the growth of wireless communication modules and the transformation of handsets and internet of things ("IOT") terminals business. While the new businesses of IOT system and online-to-offline ("O2O") business and intelligent manufacturing business did not progress satisfactorily and failed to contribute sufficient revenue and a reasonable profit to the Group, the Group's revenue still achieved a solid rise while gross profit and total profit of the Group basically stayed flat as compared with that of last year.

### Handsets and IOT terminals business

The Group started with the provision of mobile handset original design manufacturer ("ODM") services 15 years ago, and had three stages of development with each stage spanning around five years. During the first stage, the Group operated in the form of an independent design house ("IDH") providing research and development ("R&D") services for small and medium customers, turnkey solutions for handsets and full set of raw materials or components of handsets. The IDH operation mode was not involved in the production of fully-completed mobile handsets, thus the Group was able to avoid intellectual property disputes. The second stage was characterised by the operation of its ODM services. During the second stage, the Group served top-tier customers in domestic and overseas markets by providing ODM services as well as the delivery of a full set of products for consumer handsets. During the third stage, the Group gradually transformed itself to venture into the IOT terminals business. In the consumer handsets segment, the Group proactively exited from its low-end to mid-range handsets business, which had high risk yet low gross profit margin, and focus on the high-end handsets business only, particularly the high-end handsets with retail prices from US\$1,000 to US\$2,000. In 2017, the IOT/industrial application terminals business contributed a major proportion of the revenue and gross profit in the handsets and IOT terminals business segment.

### 業務回顧

本集團業務轉型,經過多年的努力和耕耘,已初見成效。2017年在受到全球經濟環境挑戰,匯率大幅波動及市場競爭日益激烈等諸多不利因素的影響下,本集團實現營收3,258,500,000港元,較去年增加19.6%。毛利額395,200,000港元,較去年減少1.6%。這首先是無線通訊模組業務的增長,也得益於手機及物聯網終端業務轉型所帶來的成效。雖然物聯網系統及運營業務及智能製造業務的新業務發展不盡人意,未能為集團貢獻足夠的營收及合理利潤,但是本集團的營收仍較去年有一定幅度的上升,本集團的毛利額和總利潤與去年基本持平。

### 手機及物聯網終端業務

本集團15年前以手機研發代工起家,經歷三個階段,每一階段大約五年。第一階段是獨立設計公司(IDH)模式,為中小型客戶做研發代工,提供手機的整體解決方案和整套的原材料或組件。IDH的模式不生產手機整機,因此可以規避知識產權糾紛。第二階段是原設計及生產代工(ODM)模式,本集團面向國內外頂級客戶,提供設計及生產代工,最終交付整機的服務,代工產品全是消費類手機。第三階段本集團逐步轉型物聯網終端,在消費類手機市場上,主動放棄了低利潤高風險的中低檔手機業務,只保留高端,特別是零售價在一兩千美元以上特高端手機。至2017年度,在手機及物聯網終端板塊中,物聯網/行業應用終端的營收和毛利已佔絕對比重。

In 2017, the sales volume of this business segment declined by 46.2% year-on-year and its average selling price escalated by 100% year-on-year. Revenue dropped by 15.3%. Gross profit margin was 12.7% and remained at a similar level as last year. The decline in revenue was due to the great drop in the revenue contribution from consumer handsets, which largely accounted for last year's revenue. The revenue for this year was mainly derived from the IOT/industrial application terminals and some differentiated high-end handset products, with higher selling prices and gross profit margins but much lower shipment volumes. Moreover, many components from the upstream supply chain were in serious shortage and the price of some components such as memories surged substantially starting from the second half of the year 2016. Fortunately, the IOT/industrial application terminals with a higher gross profit margin offset the effects caused by the above negative factors, so the gross profit margin was similar to that of last year.

該板塊2017年銷售數量較去年減少46.2%,平均銷售單價較去年提升100%,營收減少15.3%,毛利率12.7%與去年基本持平。原因在於去年營收中還有大量的消費類手機,而今年消費類手機已經很少,今年營收的主要構成為物聯網/行業應用終端及一些差異化的高端手機產品。該類產品平均售價和毛利率都要好於消費類手機,但出貨數量遠遠不及,引起營收下滑。另外從2016年下半年開始,很多上游供應鏈大面積缺貨,記憶體等元器件出現大幅漲價,所幸的是物聯網/行業應用終端的毛利率較高,抵消了上述不利因素的影響,故毛利率水平還能與去年相若。

The Group has adhered to its development strategies consistently in recent years. It has retained the high-end handsets ODM business and at the same time has vigorously developed the IOT/industrial application terminals business. With the maturity of the 5G and NB-IOT standards, the IOT market has huge growth potential, in particular for product areas such as scan, mobile Point of Sale ("POS"), logistics and Internet of Vehicles ("IOV") terminals. Furthermore, products such as dedicated enterprise intercom network terminals, outdoor waterproof, dust-proof and shock resistant terminals, vehicle terminals and augmented reality terminals for industrial enterprises have vast room for development. In recent years, the Group has continued to invest in those areas and its products have gained first-mover advantages in terms of shipments. The IOT terminals and industrial application terminals business had fast growth in Europe, America and Japan. In light of this, apart from continuously prospecting for new IOT terminal customers in China, the Group has also targeted mainly the developed regions such as Europe, America and Japan as its main overseas expansion directions through its sales network and agency appointments. As the Group pushes ahead with developing its IOT terminals business, it has also grasped opportunities to develop quality high-end consumer ODM handsets in order to maintain its economies of scale and boost the competitiveness of its supply chain. With enormous market potential and first-mover advantages, the Group believes that this business segment should continue to expand.

本集團仍會堅持近幾年一貫的發展策略,在保 持高端手機ODM業務的同時,大力發展物聯 網/行業應用終端。隨著5G和NB-IOT等標準 的日漸成熟,物聯網市場發展潛力巨大。特別 是在掃描、移動銷售時點情報系統(POS)、物 流以及車聯網終端領域。而在集團(企業)專用 對講終端、戶外三防終端、車載終端、工業企 業用的擴增實境(AR)終端等領域也存在很大的 發展空間。近幾年,本集團在這些領域都有持 續投入,且產品已形成出貨具有一定的先發優 勢。物聯網終端和行業應用終端業務在歐洲、 美洲、日本等市場發展較快。因此,本集團 除了不斷在國內開拓更多的物聯網終端客戶機 會,也把歐美日等發達地區作為現階段的海外 主攻方向,通過自建銷售網路和代理顧問等方 式,尋找更多的生意機會。在大力發展物聯網 終端業務的同時,仍會把握優質高端的消費類 手機ODM機會,以此保持規模效應,增加供 應鏈的競爭力。憑藉巨大的市場空間和先發優 勢,本集團堅信在此項業務上會有所斬獲。



### Wireless communication modules business

The wireless communication modules business refers to the R&D and sales of 2G, 3G and 4G wireless communication modules and Global Navigation Satellite System ("GNSS") modules business operated by the Group's subsidiary, Shanghai Simcom Wireless Solutions Limited.

In 2017, revenue of this business segment increased by 78.5%. Gross profit margin dropped to 8.8% when compared with that of last year. The growth in revenue was attributable to the continued booming development of the global IOT market and the rising demand for the Group's wireless communication modules in domestic and overseas markets, particularly the significant growth in 2G modules for bike sharing and smart home applications in People's Republic of China ("China" or "PRC") and the 4G modules for intelligent meter, IOV and intelligent POS applications. In the bike sharing market, the Group has captured most of the market share through its strong support to its top three customers in that sector. This business segment experienced a substantial increase in revenue, but the gross profit margin was very low due to intensifying competition among module suppliers in the bike sharing market. As the bike sharing-related business represented more than half of the shipment volume of this business segment, the gross profit margin of the whole business segment showed greater decline. Major reasons for the decline were the serious shortage and higher prices of some core components such as memories, printed circuit boards and capacitors starting from the second half of last year.

### 無線通訊模塊業務

無線通訊模塊業務指旗下芯訊通無線科技(上海)有限公司承擔的研發到經營銷售2G、3G、4G無線通訊功能及衛星導航系統(GNSS)功能的通用模塊業務。

該業務板塊2017年營收增加78.5%,毛利率 8.8%,較去年有較大幅度下降。營收的增長 源於隨著全球物聯網市場持續蓬勃發展,海內 外對本集團無線通訊模塊的需求增加,其中 以用於國內共享單車和智能家居的2G模塊和 用於智能電錶、車聯網、智能POS等應用的 4G 模塊增長尤為顯著。在共享單車市場,本 集團通過重點支持行業前大三客戶,覆蓋了整 個共享單車大部份的市場份額。雖然該業務板 塊營收大幅增長,但由於各個模塊供應商在共 享單車市場過度競爭,利潤微薄,而共享單車 相關業務佔整個板塊出貨量過半,致使整個板 塊的毛利率出現較大下降。另外從去年下半年 開始,一些核心元器件如記憶體、印刷電路板 (PCB)、電容器等都出現大面積缺貨和漲價, 這也是毛利率下降的主要原因之一。

### IOT system and O2O business

This business sector comprises of two segments: the first segment is the provision of various types of "cloud" system solutions with a back-end software system as the core; and the second segment is the provision of an O2O cloud trading platform to vending machine operators. (This business segment does not include the IOT terminals business.)

In 2017, the revenue of this business segment increased by 5.5% when compared with last year. Gross profit margin of this business segment was 12.6%, which is a significant decline when compared with last year. Overall profit of this business sector has decreased. The Group has developed mature system solutions encompassing intelligent elderly care service systems, health monitoring systems, vending machine operation services and vehicle anti-theft management systems. However, low sales revenues were recorded for these solutions in 2017 due to the absence of marketing and sales strategies.

As for the cloud trading platform, the Group has adjusted the development strategy from the originally asset-heavy operation mode of directly managing and operating vending machines and recruiting businesses for the financing of leasing investments to a one-stop-service asset-light O2O service platform. In 2017, the Group recorded a growth in the revenue derived from the provision of beverage wholesale and delivery services to vending machine operators and upgrade service for outdated vending machines. The increase in revenue was attributable to the establishment of a sub-depot by Shanghai Yunhao Trading Limited. a subsidiary of the Group, in other regions and the addition of business channels. Meanwhile, the Group eliminated the directly managed and operated vending machine outlets with poor efficiency and reduced the amount of financing leasing, that led to a non-operating loss. The operation of some sub-depots has not reached a break-even point while the necessary wages, warehousing and logistics expenses were still incurred, which dragged down the profitability of this business segment.

### 物聯網系統及運營業務

該板塊業務包括兩大部分:第一部分是向各行業提供以後台軟件系統為核心的各種「雲+端」系統級解決方案。第二部分是向售賣機運營商提供線上線下服務的雲貿平台。(本板塊不含物聯網純終端業務)

該板塊2017年營收較去年增加5.5%,毛利率為12.6%,較去年有一定幅度下降,板塊整體盈利下降。本集團已開發成熟的系統級解決方案涵蓋智能家居養老,健康監護,售賣機運營和車輛防盜管理等領域,但市場銷售尚未打開,未能在2017年給集團帶來可觀的營收。

雲貿平台,隨著集團發展思路由原來的「直接管理運營售賣機和融資租賃招商加盟的重資產運營模式」轉變為「線上線下服務平台的輕資產模式」。2017年,為售賣機運營商提供飲料批發配送服務和對老款式售賣機改造服務等業務的營收有所增長,這得益於上海雲灝貿易有限公司(本集團之附屬公司)外地分倉的建立和業務管道的增加。同時集團撤銷了效益不佳的直接管理運營售賣機網點,收縮融資租賃規模,引起了一定金額的非經營性損失。目前一些分倉的經營尚未達到盈虧平衡點,必不可少的人工、倉儲、物流支出進一步拉低了整個板塊的盈利水平。

Chairman's Statement 主席報告

### Intelligent manufacturing business

The Group's intelligent manufacturing segment comprises of three business units. The first business unit is engaged in producing automated equipment based on integrated robotic applications, which would be used to replace operations in the production line that are labour intensive. This has served as a starting point for the Group to enter the intelligent manufacturing market and the Group possesses significiant market shares in the global market. The second business unit is committed to developing optical system products, which are focusing on machine vision and artificial intelligence ("AI") technology intended to replace a large number of visual inspection workers in the production line. However, this unit has been unable to secure major orders and continued investment in R&D resources is still needed. The third business unit aims to tap the industrial internet intellectual system through the development of the back-end software to replace or assist simple and straightforward computer operations for a white-collar worker in manufacturing or supplychain management, such as a planner and a warehouse manager. This business unit has not generated actual revenue as it is still at the optimisation and marketing stage.

In 2017, turnover in this segment declined by 29.3% compared with that of the previous year, while its gross profit margin was similar and overall profit dropped. As the China government implemented a deleveraging policy in 2017, most manufacturing companies became more prudent in equipment investments, which suppressed the market demand. Many traditional mechanical assembly companies in China rushed to develop intelligent and automated manufacturing, which fueled competition and triggered a price war. As the Group assigns top priority to product quality and customer reputation, it has forfeited some business opportunities that could only be won with low prices. Besides, several automation companies that the Group acquired two years ago recorded losses, because they are currently managed by joint venture partners and operating beyond its effective control. Therefore, the factors above have contributed to segmental turnover and overall profit falling below expectation, and to some extent lower than that of last year. Despite the fierce competition from other players, the Group managed to stabilise the gross profit margin, capitalising on its technology edge and strong reputation in the market.

### 智能製造業務

目前本集團的智能製造業務分三個事業部。第一事業部是:以機器人集成應用為主的自動化成套設備用來代替生產在線的大量的操作工。這是集團進入智能製造的切入點,現擁有重大的全球市場佔有率。第二事業部是:以機器視覺和人工智能技術為中心的視覺系統產品用以代替生產在線大量的目測檢查工。目前尚未打開市場承接大額訂單,仍需持續投入研發資源。第三事業部是:開發後台軟件為中心的工業互聯網智能系統,用以取代或者幫助企業白領如計劃員、倉管員在計算機前簡單乏味的操作。目前仍然處於完善和市場推廣階段,未產生實際收入。

該板塊2017年營收較去年減少29.3%,毛利率水平和去年基本持平,板塊整體盈利下降。2017年,由於國內政府大力推動金融去槓桿政策,大部分製造業企業對設備類投資相對謹慎,抑制了市場的需求。國內傳統機械裝配製造企業大量湧入智能製造行業,帶動行業競爭加劇,價格比拼提前來到。本集團注重產格對其所以有效控制,出現虧損。上述幾項原因使該板塊的營收及整體盈利水平都不及預期,且較去年有一定幅度的下降。在同業競爭不斷加大的背景下,本集團依託自身的技術優勢,良好的市場口碑保持了相對穩定的毛利率水平。

The Group has continued to develop our intelligent manufacturing business. To better serve its customers, the Group has established two automation business bases, one in Qingpu in Eastern China and one in Songshanhu in Southern China, to form a complete platform for R&D and sales. The Group is using these bases to optimise corporate structure, reform the operational model, and reinforce its leading presence in the 3C products testing sector. It is striving to secure large international EMS providers as customers and extend the applications of its products to other industries including optical AI, intelligent logistics, intelligent storage, etc.

本集團仍將繼續大力發展智能製造業務,為了 更好的服務客戶,本集團已相繼建立了華東青 浦、華南松山湖兩個自動化業務基地,搭建了 完整的研發和銷售平台。本集團將依託兩個業 務基地優化組織架構,革新經營模式,立足3C 產品測試行業的領先地位,努力開拓國際大型 EMS代工客戶,同時將視覺人工智能、智能物 流、智能倉儲等產品的應用向多行業延伸。

### **Properties development**

As at 31 December 2017, "The Riverside Country" (晨興。翰林水郡), located at No. 32 Shenbei Road, Shenyang City, the PRC, has a total of 1,842 residential units in all its four phases, of which 1,680 units had been sold. Total area of approximately 25,000 square meters were not yet sold or not yet delivered to the buyers. The group has 60% ownership on this project.

As at 31 December 2017, "Seven River in Sweet" (七里香溪), located at No. 85 East Jichuan Road, Taizhou City, the PRC, has a total of 779 units, of which around 96% residential units, 1% shops and 3% commercial units. 758 units had been sold, of which around 96% residential units, 1% shops and 3% commercial units. Total area of approximately 29,000 square meters were not yet sold or not yet delivered to the buyers. The group has 100% ownership on this project.

The revenue of properties development for 2017 was amounted to HK\$306.4 million (2016: HK\$192.4 million) with gross profit margin of 16.9% (2016: 12.1%).

### 物業發展

截至二零一七年十二月三十一日,位於中國瀋陽市沈北路32號的「晨興。翰林水郡」項目,四期共有1,842個住宅單位,其中已出售了共1,680個住宅單位。未出售或未交付給買家的單位佔總面積約為25,000平方米。本集團對此項目有60%的擁有權。

截至二零一七年十二月三十一日,位於中國泰州市濟川東路85號的「七里香溪」項目,共有779個單位,其中約96%為住宅單位、1%為商鋪及3%為商業單位。共出售的單位有758個,其中約96%為住宅單位、1%為商鋪及3%為商業單位。未出售或未交付給買家的單位總面積約為29,000平方米。本集團對此項目有100%的擁有權。

二零一七年物業發展的銷售額為306,400,000 港元(二零一六年:192,400,000港元),毛利 率為16.9%(二零一六年:12.1%)。

### **PROSPECTS**

In executing its transformation strategy and facilitating the development of the wireless communication modules business, the Group has entered into a sale and purchase agreement with 深圳日海通訊技術股份有限公司 (Shenzhen Sunsea Telecommunication Co., Ltd.\*), to dispose 100% equity interests in Shanghai Simcom Wireless Solutions Limited ("Simcom Wireless"), a subsidiary of the Group. Further details are disclosed in the section of "Material Acquisition and Disposal of Subsidiaries and Associated Companies" in this announcement.

Prior to this disposal, the Group's wireless communication modules business had covered the entire business chain of wireless communication modules operations, from product development (including product planning and specifications), procurement of raw materials, production processing (including logistics and delivery of finished products) to sales operations. Upon completion of this disposal, the Group will only be responsible for procurement of raw materials and production processing (including logistics and delivery of finished products). The wireless communication modules business is expected to remain as one of the Group's business segments subsequent to this disposal. Its turnover should not drop significantly compared with the period before this disposal, however its business nature will change from an original brand manufacturer ("OBM") to an electronics manufacturing services ("EMS") provider. By then, the gross profit margin would drop notably but the Group would no longer need to bear the huge R&D expenses and marketing costs of the modules business, nor the inventory risk of raw materials.

This disposal will not affect the Group's handsets and IOT terminals business. In the future, the Group will continue to focus on the IOT/ industrial terminals markets, in order to better understand the demand and weakness of different business segments. The Group will also increase the investments in R&D, and actively plan and develop terminals or specialised modules that suit the markets. Regarding market development, the Group will focus more on securing new customers in overseas markets. The proceeds from the above mentioned disposal will be used to build an operations center in Dongguan and a factory to upgrade handsets. The Directors believe that the Group can stand out amidst the keen competition of the IOT terminals market.

### 展望

為了配合集團的轉型策略並使無線通訊模塊業務得到更好的發展,日前,集團與深圳日海通訊技術有限公司訂立買賣協議:出售旗下子公司芯訊通無線科技(上海)有限公司(「芯訊通無線科技」)(本集團之附屬公司)100%的股權。進一步詳情披露於本公告內「重大收購及出售附屬公司及聯營公司」一節。

本次出售前,本集團無線通訊模塊業務涵蓋了無線通訊模塊業務運作整個業務鏈,也就是從產品研發(含產品規劃、產品定義)、備料採購、生產加工(含製成品物流發貨)直到經營銷售。而交割之後,本集團只負責備料採購、生產加工(含製成品物流發貨)。預計此次出售後,無線通訊模塊業務仍然是本集團幾個業務板塊之一,其營收規模將與出售前相比下降不多,但是業務性質將由自有品牌的生產商(OBM)轉為電子製造服務供應商(EMS)。屆時預計毛利率將大幅降低,但同時本集團不需要再承受模組業務巨額研發費用和營銷費用,而且不需要承擔備料庫存的風險。

此次出售不會影響本集團手機和物聯網終端業務。本集團將繼續聚焦物聯網/行業終端市場,深入瞭解各業務的需求和痛點,增加研發投資,主動規劃並研發出適合該市場的終端或專用模块。在市場的開拓發展方面,集團將更注重開拓海外新市場新客戶。有了出售後,所得的新資金的支持,可用於建設東莞運營中心及改造手機終端製造工廠,董事有信心本集團定能在物聯網終端市場的慘烈激烈競爭中脱穎而出。

Regarding the IOT system and O2O business, the Group will continue to bolster the R&D and marketing of IOT back-end software and expand the cloud computing and big data service platform. The Group will also further expand the ancillary applications of self-developed IOT terminals for different industries, so as to bring new business opportunities to the IOT system and O2O business segment. At the same time, the Group will retain the service platform model for automatic vending machines, in order to build an integrated service platform to focus on serving small-to-medium automatic vending machine operators and beverage manufacturers. This asset-light operation mode is expected to optimise the Group's IT technical strengths and control operational risks while facilitating overall business operations.

物聯網系統及運營業務,本集團繼續加強物聯網後台系統軟件的研發與市場推廣,擴展雲計算和大資料服務平台。深化與本集團自主研發的各行業物聯網終端配套應用,以此為物聯網系統及運營業務板塊帶來新的業務機會。同時將堅持自動售貨機業務的服務平台模式,打造一個面向中小規模自動售貨機運營商以及飲料廠商的綜合服務平台。可以預期,此種輕資產的運作模式更能夠發揮本集團資訊科技技術的優勢且運作風險可控,更加健康。

Intelligent manufacturing business is the Group's latest business pursuit and has strong potential for development. After years of efforts, out of three production lines, the automated robotic line has carved out market share in the handsets manufacturing industry. The performance of the optical technological products has proven that they can create huge value for customers. Industrial internet products have been increasingly deployed at our factories. After several years' of hard work, the entire business team has grown into a top unit integrating R&D, manufacturing, sales and after-sales functions. Transformation to intelligent robotic manufacturing has become a major trend in manufacturing within China, thus, there will be a strong demand for intelligent manufacturing and Al in the future. The competition in the industry among homogeneous products or for talent is expected to become more intense. Facing a fiercely competitive market, the Group's intelligent manufacturing team has made the necessary full preparation and the Group, for its part, will nurture their entrepreneurial "can-do" spirit through more effective solutions. Thus the Group expects the intelligent manufacturing business will develop rapidly in the next few years.

智能製造業務是本集團最新業務領域,有著巨 大的發展潛能。數年間的努力,三個產品線 中,機器人自動化生產線已經在手機製造業中 搶佔了市場。視覺技術產品已經在客戶端證明 了該產品可以為客戶帶來的巨大價值。工業互 聯網的產品也已在自身工廠逐步應用。經過幾 年的努力,整個業務團隊已經成長為一支集研 發、生產、銷售、售後與一體的優質團隊。當 前國內製造業正處於機器人智能改造的風口浪 尖,未來智能製造、人工智能的需求將有爆炸 式的增長。同樣可以預見,行業競爭、同質化 產品競爭、人才競爭也會愈演愈烈。本集團的 智能製造團隊已經做好了充分的準備,以更有 效的方案激勵員工發揮創業者的拼搏精神,來 面對未來殘酷激烈的市場競爭。本集團預計未 來幾年智能製造業務將會有爆發式快速增長。

Chairman's Statement 主席報告

More than ten years ago, the Group has constructed its headquarters in Shanghai, namely SIM Technology Building Block A and Block B located at No. 633 Jinzhong Road, Changning District, Shanghai City, the PRC, which were intended partly for internal use and partly for leasing. The property market in China had not surged at that time, so the leasing area was relatively small and the rent was low. The Group didn't launch a dedicated leasing business, rather it was considered as other income only. However, the property market in China has become more and more prosperous in recent years with a substantial increase in rent. Thus, the Group has moved part of the staff to the Qingpu factory as the rent there is lower, and subsequently enlarged the leasing area at the Shanghai headquarters. To utilise our resources more effectively, the Group is developing the property leasing business by leasing out the spare space at factories and other buildings. As at 31 December 2017, part of SIM Technology Building is held on medium-term lease as investment properties for leasing purpose. At the same time, the Group plans to invest and build a southern base in Dongguan, and parts of the properties are to be earmarked for the leasing business as well. The Group believes that the property market in China has passed the stage of explosive growth, nonetheless will keep growing steadily, rental income will become a stable growth business of the Group.

十多年前,集團於上海長寧區金鐘路633號興 建總部上海晨訊科技大樓A,B棟的時候早已 規劃為部分自用,部分出租。由於當時國內的 地產市場並未開始急速發展, 出租的面積相對 較少,租金相對較低,集團並沒有即時開展租 賃業務,只是作為其他收入來考慮。近年來國 內的地產市場發展愈來愈蓬勃,租金大幅上 升,集團把部分員工搬遷到租金較低的青浦工 廠,上海總部可用於出租的物業面積也有所增 加。為了令公司的資源帶來更大的效益,集團 將持續出租一些已騰出的大樓或廠房用於發展 物業租賃業務。於二零一七年十二月三十一 日,部分晨訊大樓乃根據中期租約持有用於出 租的投資物業。同時,集團正計劃在東莞投資 建設南方基地,也將有部分物業用於發展租 賃業務。集團相信雖然國內物業市場暴漲階段 已經過去,但是未來仍將會維持健康增長,因 此,租賃收入將會成為集團一項穩定及持續增 長的業務。

Looking ahead, the Group will enhance its business transformation, develop value-added businesses and refine its business model as it tightens control and management of costs and expenses. While transformation can be painful for a fresh start, so every staff should have the ambition to start a new business, embrace the change and bear the responsibilities. We firmly believe that the Group will create greater economies of scale to accommodate the continuous development of its business.

展望未來,本集團將著力加大業務轉型的步伐,開拓高附加值的業務及模式,對成本和費用實施精細化的管理和控制。轉型是痛苦的,猶如鳳凰涅盤,但集團每位員工都懷著二次創業崛起的雄心,擁抱變化,承擔責任,我們堅信本集團將開拓更廣闊的發展空間,基業長青。

The management believes the development in the past year has proved that the new development directions and strategies of the Group are correct. The completion of business transformation achieved initial results that laid the foundation for the sustainable development. The management expects that new businesses will hurl the Group's development to new heights again in the next few years.

On behalf of the Board, I would like to express my cordial appreciation to all members of the management and the employees for their efforts and dedication throughout the Year. Finally, I would like to thank the financial institutions, Shareholders and investors for their continuous support and confidence in us.

### FINANCIAL REVIEW

During the Year, the revenue from handsets and IOT terminals business, wireless communication modules business, IOT system and O2O business and intelligent manufacturing business ("Core Business") increased by 16.6% to HK\$2,952.1 million (2016: HK\$2,531.9 million). The revenue from the sale of residential units in PRC amounted to HK\$306.4 million (2016: HK\$192.4 million). The total revenue of the Group for the Year, included revenue of Core Business and properties development, amounted to HK\$3,258.5 million (2016: HK\$2,724.4 million).

The gross profit for Core Business of the Group for the Year decreased by 9.2% year-on-year to HK\$343.5 million (2016: HK\$378.6 million). The gross profit margin for Core Business decreased to 11.6% (2016: 15.0%). The overall gross profit margin of the Group for the Year was 12.1% (2016: 14.7%).

The Group achieved a profit attributable to owners of the Company which increased year-on-year by 44.5% to HK\$111.7 million (2016: HK\$77.3 million) for the Year. The basic earnings per share for the Year was HK4.36 cents (2016: HK3.02 cents).

### 財務回顧

於本年度,銷售手機及物聯網終端業務、無線通訊模塊業務、物聯網系統及運營業務及智能製造業務(「核心業務」)之收入增加16.6%至2,952,100,000港元(二零一六年:2,531,900,000元)。來自銷售位於中國之住宅單位之收入為306,400,000港元(二零一六年:192,400,000港元)。本集團於本年度之總收入(包括核心業務及物業發展的收入)為3,258,500,000港元(二零一六年:2,724,400,000港元)。

本集團於本年度之核心業務的毛利按年減少9.2%至343,500,000港元(二零一六年:378,600,000港元)。核心業務的毛利率減少至11.6%(二零一六年:15.0%)。本集團於本年度整體毛利率為12.1%(二零一六年:14.7%)。

於本年度,本集團錄得本公司擁有人應佔溢利 按年增加44.5%至111,700,000港元(二零一六 年:77,300,000港元)。本年度每股基本盈利 為4.36港仙(二零一六年:3.02港仙)。



### Research and development expenses

In 2017, the Group mainly focused on the development of intelligent manufacturing businesses. The number of design and development team members was 840 (2016: 860) in 2017. Total R&D expenses of the Group, which amounted to HK\$90.6 million (2016: HK\$102.2 million), represented 2.8% (2016: 3.8%) of the Group's revenue.

### Selling and distribution costs

The selling and distribution costs of the Group for the Year increased by 6.3% to HK\$144.4 million (2016: HK\$135.9 million). The ratio of the selling and distribution costs over revenue in 2017 was 4.4 % (2016: 5.0%).

### **Administrative expenses**

The Group's administrative expenses for 2017 decreased by 2.4% to HK\$122.2 million (2016: HK\$125.2 million), representing 3.8% (2016: 4.6%) of the revenue.

### 研究及開發費用

於二零一七年,本集團集中在智能製造業務的研發,於二零一七年,設計及開發團隊共有840名成員(二零一六年:860名)。研發開支為90,600,000港元(二零一六年:102,200,000港元),佔本集團收入約2.8%(二零一六年:3.8%)。

### 銷售及分銷成本

本集團本年度的銷售及分銷成本增加6.3%至144,400,000港元(二零一六年:135,900,000港元)。於二零一七年,銷售及分銷成本佔收入的比例為4.4%(二零一六年:5.0%)。

### 行政開支

於二零一七年,本集團的行政開支減少 2.4%至122,200,000港元(二零一六年: <math>125,200,000港元),佔收入的3.8%(二零一六年: <math>4.6%)。

### Handsets and IOT terminals business

During the Year, since more customers have shifted towards using IOT/industrial application terminals and some differentiated high-end handsets products, the Group no longer developed consumer handsets that are homogeneous and single model with bulk shipment, which generates narrow gross profit margins. However, the IOT/industrial application terminals and some differentiated high-end handset products have higher selling prices and gross profit margins but much lower shipment volumes. As a result, the revenue of this segment decreased significantly year-on-year by 15.3% to HK\$1,076.9 million (2016: HK\$1,271.1 million) in 2017. Nevertheless, as the application terminals having higher average selling price and profit margin, the overall gross profit margin of this business segment increased slightly to 12.7% (2016: 12.4%) for the Year. The revenue of ODM business contributed to approximately 72% of the revenue of this segment in 2017 (2016: 73%).

### Wireless communication modules business

Due to the increasing demand for the Group's wireless communication modules from domestic bike sharing industry, revenue of this segment increased year-to-year by 78.5%. However due to the declining average selling price of 2G and other low-end modules, the gross profit margin decreased to 8.8% (2016: 14.5%).

### 手機及物聯網終端業務

於本年度,由於本集團持續將客戶群進一步轉向物聯網/行業應用終端及一些差異化的高端手機產品,不再開發同質化單款大量低毛利率的中低端消費類手機。雖然物聯網/行業應用終端及一些差異化的高端手機產品平均售價和毛利率都要好於消費類手機,但出貨數量遠遠不及。二零一七年此分部之收入按年大幅減少15.3%至1,076,900,000港元(二零一六年:1,271,100,000港元)。但受惠於應用終端的平均售價及毛利率較高,該業務分部本年的整體毛利率輕微加至12.7%(二零一六年:12.4%)。於二零一七年,ODM業務收入佔此分部收入約72%(二零一六年:73%)。

### 無線通訊模塊業務

由於國內共享單車業務對本集團的無線通訊模塊的需求持續增加,本分類之收入按年增加78.5%。但是,由於2G及其他低端模塊的平均售價(ASP)呈現下降趨勢,毛利率下降至8.8%(二零一六年:14.5%)。

### IOT system and O20 business

During the Year, the revenue of this segment increased 5.5% to HK\$318.9 million (2016: HK\$302.3 million). That was mainly due to the increase in establishment of a sub-depot by the Group in other regions and the addition of business channels. Meanwhile, the Group eliminated the directly managed and operated vending machine outlets with poor efficiency and reduced the amount of financing leasing, leading to a non-operating loss. The operation of some sub-depots has not reached a break-even point while the necessary wages, warehousing and logistics expenses were still incurred, which dragged down the profitability of this business segment. The gross profit margin for the Year decreased to 12.6% (2016: 15.2%).

#### Intelligent manufacturing business

As the China government implemented a deleveraging policy in 2017, most manufacturing companies became more prudent in equipment investments, which suppressed the market demand. Besides, several automation companies that the Group acquired two years ago recorded losses, because they are currently managed by joint venture partners and operating beyond its effective control. As a result, the revenue for the Year of this segment decreased by 29.3% to HK\$101.4 million (2016: HK\$ 143.5 million), while gross profit decreased by 30%. The gross profit margin also decreased to 38.7% (2016: 39.1%).

### 物聯網系統及運營業務

於本年度,此分部的收入增加5.5%至318,900,000港元(二零一六年:302,300,000港元),主要因為本集團外地分倉的建立和業務管道的增加。同時集團撤銷了效益不佳的直接管理運營售賣機網點,收縮融資租賃規模,引起了一定金額的非經營性損失。目前一些分倉的經營尚未達到盈虧平衡點,必不可少的人工、倉儲、物流支出進一步拉低了整個板塊的盈利水平。本年度毛利率下降至12.6%(二零一六年:15.2%)。

### 智能製造業務

2017年,由於國內政府大力推動金融去槓桿政策,大部分製造業企業對設備類投資相對謹慎,抑制了市場的需求。另外,兩年前併購的幾家自動化公司由合資方經營管理,本集團未能對其形成有效控制,出現虧損。因此,本年度該分部收入減少29.3%至101,400,000港元(二零一六年:143,500,000港元),而毛利減少30.0%及毛利率也減少至38.7%(二零一六年:39.1%)。



# LIQUIDITY, FINANCIAL RESOURCES AND CAPITAL STRUCTURE

### Liquidity

As at 31 December 2017, the Group had bank balances and cash of HK\$417.1 million (31 December 2016: HK\$249.1 million), among which 88.3% was held in Renminbi, 11.5% was held in US dollars and the remaining balance was held in Hong Kong dollars. As at 31 December 2017, the Group also had pledged bank deposits of HK\$30.1 million (31 December 2016: HK\$76.6 million) in Renminbi for the purpose of the Group's Renminbi borrowings. The Group intends to finance its working capital and capital expenditure plans from such bank balances. The Group has pledged certain of its assets (including property, plant and equipment, investment properties, land use rights and notes receivables) to secure the bank borrowings. The total bank borrowings of the Group amounted to HK\$84.1 million as at 31 December 2017 (31 December 2016: HK\$300.0 million), all of which HK\$62.1 million was denominated in Renminbi and HK\$22.0 million was denominated in US dollars. All of the bank borrowings were at floating interest rates and repayable within one year.

### **Operating Efficiency**

The turnover period of the inventory, trade and notes receivables, trade and notes payables of the Group for the Core Business are presented below:

In the Year, due to significant increase in sales volume, the purchase and cost of sales of the Group increased significantly. The inventory turnover period thus decreased as compared to that of year 2016.

The trade and notes receivable turnover period decreased for the Year as compared to that of year 2016 due to the significant increase in sales for the Year.

Management's Discussion and Analysis 管理層討論及分析

The trade and notes payables turnover period decreased for the Year as compared to that of year 2016 due to the decrease in average balance of trade and notes payables for the Year.

As at 31 December 2017, the current ratio, calculated as current assets over current liabilities, was 1.9 times (31 December 2016: 1.9 times).

The Group reckons that inventory turnover period, trade and notes receivables turnover period, and trade and notes payables turnover period help the Group to understand its ability to convert inventory into cash and sales and cash conversion cycle. Through reviewing the turnover periods, the Group can improve its operational efficiency. The current ratio can help the Group to understand its ability to pay short-term and long-term obligations.

### **Treasury Policies**

The Group adopts a prudent approach in its treasury policy. The Group's surplus funds are held under fixed and savings deposits in reputable banks to earn interest income. As at 31 December 2017, the Group has entrusted a total amount of HK\$36.2 million under certain asset management agreements for an investment period of one year. During the Year, the Group did not have any other security or capital investments or derivative investments.

Certain sales and purchases of inventories of the Group are denominated in US dollars. Furthermore, certain trade receivables, trade payables, bank balances and bank borrowings are denominated in US dollars, therefore exposing the Group to the currency risk of US dollars. During 2016, the Group entered into a foreign exchange forward contract of US\$20.0 million to reduce the foreign exchange exposures in US dollars. The aforementioned foreign exchange forward contract was matured on 16 November 2017 and there was no outstanding foreign exchange forward contract as at 31 December 2017. Save as disclosed, as at 31 December 2017, the Group did not use any financial instrument for hedging purpose.

由於應付貿易賬款及票據於本年度之平均餘額 減少,因此,本年度之應付貿易賬款及票據週 轉期比二零一六年減少。

於二零一七年十二月三十一日,流動比率(按流動資產對流動負債計算)為1.9倍(二零一六年十二月三十一日:1.9倍)。

本集團認為存貨週轉期、應收貿易賬款及票據 週轉期、應付貿易賬款及票據週轉期有助本集 團瞭解存貨變現能力的效率,銷售與現金周轉 週期。透過審視週轉天數將可改善本集團的營 運效率。流動比率可幫助本集團瞭解其短期及 長期償債能力。

### 庫務政策

本集團採納審慎之庫務政策。本集團之盈餘資金乃存入聲譽良好之銀行作為定期及活期存款,以賺取利息收入。於二零一七年十二月三十一日,本集團已根據若干份投資期為一年之資產管理合約委託合共36,200,000港元。於本年度,本集團並無任何其他抵押或資本投資或衍生投資。

本集團若干銷售及購買存貨以美元計值,另本 集團若干應收貿易賬款、應付貿易賬款、銀行 結餘及銀行借貸以美元計值,本集團因此承受 美元貨幣風險。於二零一六年,本集團訂立了 一份20,000,000美元的外匯長期合約,以減 低於美元的外匯風險。上述外匯長期合約已於 二零一七年十一月十六日到期。於二零一七年 十二月三十一日,概無未完成之外匯長期合 約。除已披露者外,於二零一七年,本集團無 使用任何金融工具作對沖用途。

### **CAPITAL STRUCTURE**

As at 31 December 2017, the Company had 2,559,546,300 ordinary shares of HK\$0.10 each in issue.

The Company has issued 1,650,000 ordinary shares of HK\$0.1 each upon exercise of share options of the Company during the Year.

Save as disclosed above, no shares of the Company has been issued or repurchased during the Year.

### **GEARING RATIO**

As at 31 December 2017, the total assets value of the Group was HK\$3,630.4 million (31 December 2016: HK\$3,479.8 million) and the bank borrowings was HK\$84.1 million (31 December 2016: HK\$300.0 million). The gearing ratio of the Group, calculated as total bank borrowings over total assets, was 2.3% (31 December 2016: 8.6%).

# MATERIAL ACQUISITION AND DISPOSAL OF SUBSIDIARIES AND ASSOCIATED COMPANIES

On 20 January 2017, SIM Technology Group (BVI) Limited, a wholly-owned subsidiary of the Company and u-blox AG, a wholly-owned subsidiary of u-blox Holding AG (a company listed on the SIX Swiss Exchange), entered into the technology assignment ("Technology Assignment Contract") and the asset purchase agreement ("Asset Purchase Agreement"), pursuant to which the Group has agreed to sell the Group's 2G, 3G, 4G wireless communication module and GNSS module business related technology and assets at the aggregate consideration of US\$52.5 million.

On 21 May 2017, the Group and u-blox AG have mutually agreed not to proceed with the above mentioned proposed disposal. Both parties have therefore decided to amicably terminate the Technology Assignment Contract and Asset Purchase Agreement and all ancillary agreements.

Further details of the above mentioned proposed disposal are disclosed in the announcements of the Company dated 22 January 2017 and 22 May 2017 and the circular of the Company dated 28 February 2017.

On 22 September 2017, the Company, Simcom International Holdings Limited ("Simcom International"), 上海移為通信技術股份有限公司 (Queclink Wireless Solutions Co., Ltd.\*) ("Queclink Wireless"), Richjoy Talent Limited ("Richjoy"), Shanghai Simcom Electronic Limited ("Simcom Electronic", together with Simcom Wireless as the "Target Companies") and Simcom Wireless entered into a sale and purchase agreement under which Simcom International has conditionally agreed to sell, and Queclink Wireless and Richjoy have conditionally agreed to purchase the equity interest in the Target Companies at the aggregate consideration of RMB528 million.

上述建議的出售事項之進一步詳情披露於本公司日期為二零一七年一月二十二日及日期為二零一七年五月二十二日之公告及本公司日期為二零一七年二月二十八日之通函。

於二零一七年九月二十二日,本公司、Simcom International Holdings Limited (「Simcom International」)上海移為通信技術股份有限公司(Queclink Wireless Solutions Co., Ltd.\*)(「移為通信」)、日領有限公司(「日領」)、上海芯通電子有限公司(「芯通電子」與芯訊通無線科技統稱為「標的公司」)與芯訊通無線科技訂立買賣協議,據此,Simcom International已有條件同意出售而移為通信及日領已有條件同意購買標的公司的股本權益,總代價為人民幣528,000,000元。

On 7 December 2017, the Company, Simcom International, Queclink Wireless, Richjoy, the Target Companies, Shenyang SIM Simcom Technology Limited and Shanghai SIM Technology Limited entered into a termination agreement for the above mentioned sale and purchase agreement.

Further details of the above mentioned proposed disposal are disclosed in the announcements of the Company dated 22 September 2017, 24 November 2017 and 7 December 2017.

On 21 December 2017, the Company, Simcom International (an indirect wholly-owned subsidiary of the Company), 深圳日海通訊技術股份有限公司 (Shenzhen Sunsea Communication Technology Co. Limited\*) ("Shenzhen Sunsea") (a company listed on the Shenzhen Stock Exchange), Simcom Electronic and Simcom Wireless entered into the sale and purchase agreement ("Sale and Purchase Agreement") under which Simcom International has conditionally agreed to sell, and Shenzhen Sunsea has conditionally agreed to purchase, 100% of the equity interest of Simcom Wireless ("Disposal"). It is expected that approximately 35% of the actual net gain from the disposal will be used for payment of a special interim dividend. Further details of the amount of the special interim dividend and the record date of the entitlements will be announced by the Company after completion. Details of the Disposal are disclosed in the announcements of the Company dated 21 December 2017 and 13 February 2018 and the circular of the Company dated 18 January 2018.

Save as disclosed above, during the Year, the Group did not have any material acquisition or disposal of subsidiaries or associated companies.

### SIGNIFICANT INVESTMENT

As at 31 December 2017, the available-for-sale investment represented the Group's investment in 3.41% of the shares in Shanghai Guao Electronic Technology Co., Ltd ("Shanghai Guao") ("Investment") and the Investment cost was approximately HK\$16.9 million. During 2016, Shanghai Guao became listed on the ChiNext of the Shenzhen Stock Exchange. The fair value, based on the quoted market price, of the Investment at 31 December 2017 is approximately HK\$80.3 million (31 December 2016: HK\$187.4 million). HK\$171,000 dividends was received from Shanghai Guao during the Year. Shanghai Guao specializes in the research and development, manufacturing, marketing and service of innovative financial equipment. The Group noted the development strategy of Shanghai Guao as stated in its annual report for the year 2016 issued on April 2017, that Shanghai Guao will focus on the new financial products based on its existing production system and technology reserve. Shanghai Guao will continue to develop its technology so as to improve its sales and after-sale service. Shanghai Guao will develop projects in relation to automated cash treatment.

除上述披露者外,於本年度,本集團並無任何 重大收購或出售附屬或聯營公司。

### 重大投資

於二零一七年十二月三十一日,可供出售投資 指本集團持有上海古鰲電子科技股份有限公司 (「上海古鰲」)3.41%股權(「該投資」)。該投 資之成本約為16,900,000港元。上海古鰲於 2016年在深圳證券交易所創業板上市。該投 資於二零一七年十二月三十一日之公平值(按 市場價釐定)約為80,300,000港元(二零一六年 十二月三十一日:187,400,000港元)。於本年 度從上海古鰲收取之股息為171,000港元。上 海古鰲是從事創新之金融設備的研發、生產、 銷售與服務。本集團注意到於二零一七年四月 刊發的上海古鰲二零一六年年報中所述,其發 展戰略將為根據其現有生產系統及技術儲備集 中發展新金融產品。上海古鰲將繼續發展其技 術以改善銷售及售後服務。上海古鰲將發展與 自動現金處理有關的項目。

### **EMPLOYEES**

As at 31 December 2017, the Group had approximately 2,540 (2016: 2,390) employees. The Group operates a Mandatory Provident Fund retirement benefits scheme for all its employees in Hong Kong, and provides its PRC employees with welfare schemes as required by the applicable laws and regulations of the PRC. The Group has a comprehensive training system in place that establishes a network-based career path for employees, including position and ability management, skills enhancement programme, various training opportunities, online learning programme for staff, internal promotion system, key employees development programme, succession plans for key positions and leadership development programme. The Group also offers discretionary bonuses and may grant share options under the share option scheme of the Company to its employees by reference to individual performance and the performance of the Group. Total staff costs incurred by the Group amounted to HK\$308.0 million (2016: HK\$387.5 million) during the Year.

### **EMOLUMENT POLICY**

The emolument policy of the employees of the Group is set by the human resources department. The Group seeks to provide remuneration packages on the basis of the merit, qualifications and competence of the employees.

The emoluments of the Directors and senior management of the Company are reviewed by the remuneration committee of the Board, having regard to factors including the Group's operating results, responsibilities of the Directors and senior management and comparable market statistics.

The Company adopted a pre-listing share option scheme to recognise and reward the contribution of certain Directors and employees of the Group to the growth and development of the Group. The Company has adopted share option scheme, the primary purpose of which is to motivate the eligible persons referred to in the scheme, which include executive Directors and employees of the Group, to optimise their future contributions to the Group and to reward them for their efforts. Details of the share option schemes of the Company are set out in note 36 to the consolidated financial statements.

本公司已採納一項首次公開發售前購股權計劃,以嘉許及獎勵本集團若干對本集團增長及發展作出貢獻的董事及僱員。本公司已採納一項購股權計劃,主要目的為鼓勵計劃所述包括本集團執行董事及僱員在內的合資格人士於日後為本集團帶來最大貢獻,並回報彼等所作出的努力。購股權計劃之詳情載於綜合財務報表附計36。

### **FUTURE PLANS FOR MATERIAL INVESTMENT**

As stated in the circular of the Company dated 18 January 2018, the Group intends to use part of the net proceeds from the Disposal in the following manner:

- as to approximately HK\$201.5 million for purchase of the land for the Group's operations centre in Dongguan, the PRC and the construction of the operation centre; and
- as to approximately HK\$115.1 million for (a) upgrading the production facilities of the Group in Shanghai and the above operations centre and development of an automated intelligent 3D-warehouse; (b) further implementation of the digitizating, networking and intelligent processes by Industry 4.0; and (c) enhancing the competitiveness of the high-end handsets ODM (original design manufacturing) and EMS businesses.

Save as disclosed above, the Group did not have any plans for material investment or capital assets during the Year.

### **CONTINGENT LIABILITIES**

As at 31 December 2017, the Group did not have any material contingent liabilities.

### EVENTS AFTER THE REPORTING PERIOD

On 13 February 2018, the Shareholders approved the Sale and Purchase Agreement and the transactions contemplated thereunder. Subsequent to 31 December 2017, the Disposal has been completed and the Group is in the process of assessing the relevant financial impact of the Disposal to the Group.

Details of the Disposal are disclosed in the section of "Material Acquisition and Disposal of Subsidiaries and Associated Companies" in this report and the announcements of the Company dated 21 December 2017 and 13 February 2018 and the circular of the Company dated 18 January 2018.

Save as disclosed above, there were no significant events of the Group occurred since the end of the Year.



#### **BUSINESS REVIEW**

The fair review, financial key performance indicators and indication of future development of the Group for the year ended 31 December 2017 is set out in the sections headed "Chairman's Statement" and and "Management's Discussion & Analysis" in this annual report. That discussion forms part of this Report of the Directors.

#### Principal risks and uncertainties

A number of factors may affect the results and business operations of the Group. Major risks are summarized below.

We adapt to the national plan "Made in China 2025" and extend automated manufacturing services based on our experience in traditional telecommunications and terminal manufacturing businesses. Manufacturing pipeline transformation services of our competitors in the past are developed as our new business to alleviate risks raising from slow-down in economy in the PRC.

#### Handset manufacturing overcapacity results in the trend of moving towards the downstream of the industry:

In recent years, growth of handset industry in the PRC has been declining with the economic slowdown and diminishing demographic dividend. Therefore, handset market turns from the increment market to the existing market in a short while. Besides, handsets have become more homogeneous than ever, and few customers feel the need to get the latest model. Thus, the handset market recorded a decrease in 2017, leading to merger, winding up, bankruptcy and transfer occurring from time to time among companies in the upstream and downstream of the industry chain. Overcapacity occurs immediately, which means there is too much supply in relative to demand. Meanwhile, production capacity adjustment will inevitably lead to certain risks such as diluted profits, and increase in marketing and channel's cost. People that previously engaged in ODM are moving towards the downstream of the industry, resulting in a more competitive downstream and a lower profit margin.

The Group has accelerated the transformation with more involvement in developing industrial application terminals. Currently, products applied in industry contribute more than a half of the whole telecommunications and terminal segment. We strive for first-mover advantage and a bigger market share.

2. Risks related to the expansion of automated intelligent manufacturing business:

In terms of the automated intelligent manufacturing business, we focus on the automatization of the production line of communication terminals. The Group is familiar with such modification. However, given that more enterprises are equipping themselves with auto test, our modification business is shrinking accordingly. For those manufacturers that do not have auto test, they do not feel the need to modify their production lines as their handset business is also going downhill. The risk of a shrinking business volume emerges. Meanwhile, lots of mechanical instrument manufacturers are participating in manufacturing automated intelligent products. Thus, we are expanding our business towards both the upstream and the downstream of the supply chain of communication terminals. By offering automatization services to component suppliers, we are expanding our business and diversify the product line of our automated products.

### 3. Risks related to management of receivables from the IOT operation service

In terms of the IOT operation service, we are engaged in the wholesale and logistics services of beverages and food. Currently we offer credit for payments for goods to small and medium automated vending machine operators in general, and there are risks that we are unable to collect payments for goods from such small operators. Fast payments are expected when sales are robust in peak seasons, however, payments can be slow or are even delayed when sales are sluggish in off seasons. We have a relatively large number of small and medium operators as our customers, which causes risks related to receivables.

In respect of controlling receivables of IOT, we adopt quota management system and warning management system, and require responsible divisions to maintain responding invoices properly to control risks to the reasonable limit.

#### **Key Relationships**

The Group's success also depends on the support from key relationships with employees, suppliers and customers.

#### 1. Employees

The Company is committed to value every talent and emphasizes that excellent employees are valuable assets for the Company. We pay attention to self-improvement of staff and give them a working environment full of fairness, openness, sincerity, warmth and opportunities. Our competitive remuneration system brings longterm and stable return for staff and also takes into account the long-term and stable development of the Company. We determine staffs' remuneration and promotion based on their capacity and contribution to the Group. The Company recognizes staff with outstanding performance and the same values with the Company as valuable assets. We keep trying our best to provide promising career prospect and a platform for them to display their talents fully. Therefore, the Company not only helps our employees to improve their knowledge, skills and experience through performing their own duties, but also creates good conditions in facilities and environment suitable for their development. To facilitate the proper allocation and development of high caliber talents, the Company has set up an employee career development system which focuses on both management and technical skills. Through this system, each outperforming key member can seize the opportunity to improve overall abilities by various ways. The Company aims to create conducive conditions for talents to demonstrate themselves and grow through career, and also build solid team with talents.

#### 2. Suppliers

The Company selects and enters into strategic cooperation with suppliers with good reputation in accordance with the principle of mutually beneficial cooperation and international standards such as ISO9001, ISO14001 and OHSAS18001. We use a strict social responsibility management system to manage our suppliers, ensure that the quality of materials provided by the suppliers meets our requirements and their production management systems also comply with requirements on environment, occupational health and safety management system as stated in relevant laws and regulations. We also make cost and delivery plans in advance to meet delivery demand.

#### 3. Customers

We establish complete management systems in compliance with national standards and abroad, as well as well-known clients' requirements, which cover product quality, environment, occupational health and safety, information security and product safety management. Through survey on clients' satisfaction we conduct every year, our clients express their positive feedback on quality, logistics, cost and service. Among our clients all over the world, both new and old well-known clients supervise and inspect each management system of the Company every year. Apart from this, our Company also implements Key Performance Indicator (KPI), internal control scheme, management appraisal program in every aspect. In order to continuously enhance management systems of the Company, we set up a specific department to supervise operation and pass the results to the management on a regular basis to review.

The major customers of the Group include handset manufacturers for famous domestic and overseas brands, high-end domestic brands in security, protection and monitoring, and walkie-talkie industry, domestic bike-sharing branded companies, etc. The length of relationship with the major customers of the Group are from 3 years to over 10 years. The credit terms granted by the Group to major customers are in line with those granted to other customers and the normal credit period taken on sales of goods is 0-90 days. Almost all trade receivables with major customers at 31 December 2017 were settled up to date of this report and no specific provisions are necessary for the major customers.

#### 2. 供應商

#### 3. 客戶

本集團主要客戶包括國內外知名手機品牌廠商;國內安防監控、對講領域高端品牌;國內共享單車品牌等。本集團與主要客戶之關係介於3年到10年以上,向主要客戶授出之信貸期與其他客戶及一般0至90日之售貨信貸期相符。幾乎全部截至二零一七年十二月三十一日與主要客戶的應收貿易賬款於本年報日期以結清,且無需對主要客戶作出特別撥備。

#### **Environmental policies**

Environmental protection is not only the responsibility of our business, but also the responsibility of each of us. We initiate and strive to minimize our environmental impact by using water saving facilities, saving electricity and encouraging recycle of office supplies and other materials. We also operate in strict compliance with the relevant environmental regulations and rules and possess all necessary permission and approval from the PRC regulators. The Group also has environmental policies to reduce emission, raise efficiency use of resources and reduce pollution.

#### Compliance with laws and regulations

The Group's operations are carried out by the Company's subsidiaries in the PRC while the Company itself is listed on the Hong Kong Stock Exchange. Our operations are regulated by Hong Kong and PRC laws. During the year ended 31 December 2017 and up to the date of this report, we have complied with the relevant laws and regulations that have significant impact to the Group in the PRC and Hong Kong.

In particular, as the Group's business involves manufacturing, the Group's operation is regulated by environmental protection laws and regulations in the PRC. During the year under review, the Group did not have any material non-compliance with such laws and regulations.

#### Events after the reporting period

Save as disclosed under the paragraph headed "Events after the Reporting Period" in the "Management's Discussion and Analysis" section, the discussion of which forms part of this Report of the Directors, there were no significant events after the reporting period of the Group.

### **Corporate Governance Report**

### 企業管治報告

The Company's goal is to continue to increase its transparency to the Shareholders and the public and to maintain a high standard of corporate governance. The principles of corporate governance adopted by the Group emphasise a Board with high quality, sound internal control, transparency, accountability and independence.

### COMPLIANCE WITH THE CORPORATE GOVERNANCE CODE

Save as mentioned below, the Company has complied with the code provisions laid down in the Corporate Governance Code ("Corporate Governance Code") as set out in Appendix 14 to the Listing Rules during the Year.

Code Provision of A.2.7 of the Corporate Governance Code requires the chairman of the Board to hold meetings at least annually with the non-executive Directors (including independent non-executive Directors) without the executive Directors present.

As Ms Yeung Man Ying, the chairman of the Board, is also an executive Director, the Company has deviated from this code provision as it is not applicable. Currently, the chairman of the Board may communicate with the non-executive Directors on a one-to-one or group basis periodically to understand their concerns, to discuss pertinent issues and to ensure that there is access to adequate and complete information.

In respect of code provisions A.5.1 to A.5.4 of the Corporate Governance Code, the Company does not have a nomination committee. At present, the Company does not consider it necessary to have a nomination committee as the full Board is responsible for reviewing the structure, size and composition of the Board and the appointment of new Directors from time to time to ensure that it has a balanced composition of skills and experience appropriate for the requirements of the businesses of the Company, and the Board as a whole is also responsible for assessing the independence of the independent non-executive Directors and reviewing the succession plan for the Directors, in particular the chairman of the Board.

According to the code provision E.1.2 of the Corporate Governance Code, the chairman of the Board shall attend the annual general meeting of the Company and arrange for the chairmen of the audit, remuneration and nomination committees (as appropriate) or in the absence of the chairman of such committees, another member of the committee or failing this, his duly appointed delegate, to be available to answer questions at the annual general meeting.

#### NOMINATION OF DIRECTORS

The Company does not have a nomination committee. The Board is responsible for nominating appropriate person, either to fill in casual vacancy or as an addition to the existing Directors for election by Shareholders at the general meeting of the Company.

As and when circumstances required, the Board will meet to discuss nomination of new Directors. In considering the suitability of a candidate for directorship, the Board will base on objective criteria, with due regard to the benefits of diversity, as set out in the board diversity policy of the Company ("Board Diversity Policy") as well as the requirements under the Listing Rules.

The re-election procedure set out in the Bye-laws provides that one-third of the Directors for the time being (or if their number is not a multiple of three, then the number nearest to but not less than one-third) shall retire from office by rotation provided that every Director shall be subject to retirement at least once every three years at each annual general meeting of the Company. A retiring Director shall be eligible for re-election and shall continue to act as a Director throughout the meeting at which he retires. The Directors to retire by rotation will be those who have been longest in office since their last re-election or appointment but as between persons who become or were last re-elected Directors on the same day those retire will (unless they otherwise agree among themselves) be determined by lot.

#### **BOARD DIVERSITY POLICY**

The Company continuously seeks to enhance the effectiveness of the Board and to maintain the highest standards of corporate governance and recognises and embraces the benefits of diversity in the Board. During the Year, the Board had in place the Board Diversity Policy in accordance with the Corporate Governance Code.

According to the diversity policy of the Board adopted by the Company, the Board takes into account various elements of diversity including but not limited to age, gender, cultural and educational background, skills, professional knowledge, and industry experience in determining the appointment and reappointment of the Directors and proposed candidates. All Directors appointments are based on meritocracy and due regard is given to the Board's diversity to ensure the Company can obtain the benefits of such diversity.

Board appointments will continue to be made on a merit basis. The Board will review the Board Diversity Policy on a regular basis to ensure its continued effectiveness.

#### CORPORATE GOVERNANCE FUNCTIONS

The Board is collectively responsible for performing the corporate governance functions in accordance with code provision D.3.1 of the Corporate Governance Code. During the Year, the Board has reviewed the policies and practices and compliance by the Company and has reviewed and monitored the training and continuous professional development of the Directors.

### DIRECTORS' RESPONSIBILITY FOR THE FINANCIAL STATEMENTS

The Directors are responsible for overseeing the preparation of the financial statements for each financial period which give a true and fair view of the state of affairs of the Group and of the results and cash flows for that period. In preparing the financial statements, the Directors have selected appropriate accounting policies, applied them consistently, made judgments and estimation that are prudent, fair and reasonable, ensured all applicable accounting standards are followed and prepared the financial statements on a going concern basis. The Directors are also responsible for ensuring that the Group keeps accounting records which disclose with reasonable accuracy at any time the financial position of the Group and which enable the preparation of financial statements in accordance with the applicable accounting standards and regulatory requirements.

During the Year, the company secretary of the Company has fully complied with Rule 3.29 of the Listing Rules by taking no less than 15 hours of relevant professional training.

The Directors acknowledges that it is their responsibility to maintain effective risk management and internal control system and to review them at regular intervals.

The Group's risk management and internal control system is designed to reduce risks, safeguard the Group's assets, prevent and detect fraud and protect Shareholders' investment as well as to ensure that proper accounting records are maintained and applicable legislation and regulations are complied with. During the year under review, through discussions with the management and external auditors the Board has conducted assessments and reviews of the effectiveness of the Group's risk management and internal control system in various perspectives, including, among others, financial control, operational and compliance controls and risk management. The risk management and internal control systems are reviewed by the Board annually and each review covers a whole financial year.

A bottom-up and top-down approach is utilised to ensure a holistic risk management process. The bottom-up approach is supported by key business units to identify and prioritise risks while the topdown approach reviews and assesses if risks are comprehensively identified, prioritised, and properly addressed by key business units to accomplish the Group's objectives.

The internal audit unit of the Company, which is subordinated to the Board, formulates the internal audit plan of the Group based on the strategic objectives analysis, business flow analysis, risk assessment and performance evaluation and the self-inspection mechanism with comprehensive risk management functions under the authority of the Board and the guidance of the Audit Committee. It regularly reports to the Audit Committee and the Board for its audit findings and recommendations on internal control.

During the year under review, the Board has reviewed the effectiveness of the Group's risk management and material internal controls system and is of the opinion that the resources for and qualifications of staff of the Company's accounting and financial reporting function are adequate and sufficient. Based on information furnished to it and on its own observations, the Board is satisfied with the present risk management and internal control system of the Group and considers them effective and adequate. During the year under review and up to the date of this annual report, nothing has been found which requires substantial improvement.

Annual general meeting of the Company ("Annual General Meeting") provides a good opportunity for communications between the Board and Shareholders. Shareholders are encouraged to attend the Annual General Meeting. Notice of the Annual General Meeting and related papers are sent to the Shareholders at least 20 clear business days before the meeting and the said notice is also published on the websites of the Stock Exchange and of the Company. The Chairman and Directors will answer questions on the Group's business at the Annual General Meeting. External auditors will also attend the Annual General Meeting.

Pursuant to Rule 13.39(4) of the Listing Rules, any vote of Shareholders at a general meeting must be taken by poll. Therefore, all the resolutions put to the vote at the Annual General Meeting will be taken by way of poll.

The poll is conducted by the Company's registrars and the results of the poll will be published on websites of the Stock Exchange and the Company. Financial and other information is made available on the Company's website and updated regularly. Specific enquiries and suggestions by Shareholders can be sent in writing to the Board or the Company Secretary at the Company's head office and principal place of business in Hong Kong at Unit 2908, 29th Floor, 248 Queen's Road East, Wanchai, Hong Kong.

- Shareholder(s) holding at the date of deposit of the requisition not less than one-tenth of the paid-up capital of the Company carrying the right of voting at general meetings of the Company shall at all times have the right, by written requisition sent to the Company's head office and principal place of business in Hong Kong at Unit 2908, 29th Floor, 248 Queen's Road East, Wanchai, Hong Kong, for the attention to the Board or the Company Secretary, to require a special general meeting to be called by the Board for the transaction of any business specified in such requisition; and such meeting shall be held within two (2) months after the deposit of such requisition.
- The written requisition must state the purposes of the meeting, and must be signed by the Shareholder(s) concerned and may consist of several documents in like form, each signed by one or more of those Shareholder(s).
- 3. The requisition will be verified with the Company's branch share registrar and upon their confirmation that the requisition is proper and in order, the Company Secretary will ask the Board to convene a special general meeting by serving sufficient notice in accordance with the statutory requirements and the Listing Rules to all the registered Shareholders. On the contrary, if the requisition has been verified as not in order, the Shareholder(s) concerned will be advised of this outcome and accordingly, a special general meeting will not be convened as requested.

- B. Procedures for Shareholders to make proposals at general meeting other than a proposal of a person for election as Director
- The Shareholder(s) holding not less than one-twentieth of the total voting rights of those Shareholders having the right to vote at such meeting or not less than one hundred Shareholders, at the expenses of the Shareholder(s) concerned, can submit a written requisition to move a resolution at a general meeting.
- 2. The written requisition must state the resolution, accompanied by a statement of not more than 1,000 words with respect to the matter referred to in the proposed resolution, signed by all the Shareholder(s) concerned and may consist of several documents in like form (which between them contain the signatures of all the Shareholder(s) concerned).
- 3. The written requisition must be deposited at Unit 2908, 29th Floor, 248 Queen's Road East, Wanchai, Hong Kong, the head office and principal place of business of the Company in Hong Kong, for the attention of the Company Secretary not less than six weeks before the meeting in the case of a requisition requiring notice of a resolution and not less than one week in the case of any other requisition.

On the contrary, if the requisition has been verified as not in order, the Shareholders concerned will be advised of this outcome and accordingly, (i) the proposed resolution will not be included in the agenda for the Annual General Meeting; or (ii) a special general meeting will not be convened as requested.

#### **OPINION**

We have audited the consolidated financial statements of SIM Technology Group Limited (the "Company") and its subsidiaries (collectively referred to as the "Group") set out on pages 76 to 205, which comprise the consolidated statement of financial position as at 31 December 2017, and the consolidated statement of profit or loss, consolidated statement of profit or loss and other comprehensive income, consolidated statement of changes in equity and consolidated statement of cash flows for the year then ended, and notes to the consolidated financial statements, including a summary of significant accounting policies.

In our opinion, the consolidated financial statements give a true and fair view of the consolidated financial position of the Group as at 31 December 2017, and of its consolidated financial performance and its consolidated cash flows for the year then ended in accordance with International Financial Reporting Standards ("IFRSs") and have been properly prepared in compliance with the disclosure requirements of the Hong Kong Companies Ordinance.

#### **BASIS FOR OPINION**

We conducted our audit in accordance with International Standards on Auditing ("ISAs"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Consolidated Financial Statements section of our report. We are independent of the Group in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (the "Code"), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### 意見

#### **KEY AUDIT MATTERS**

Key audit matters are those matters that, in our professional judgement, were of most significance in our audit of the consolidated financial statements of the current period. These matters were addressed in the context of our audit of the consolidated financial statements as a whole, and in forming our opinion thereon, and we do not provide a separate opinion on these matters.

#### Key audit matter

#### Valuation of inventories

We identified the valuation of inventories as a key audit matter because of the significant judgement exercised by management in determining the appropriate levels of allowance.

The carrying amount of inventories is approximately HK\$758,531,000 as at 31 December 2017. The management of • the Group reviews an ageing analysis of inventories at the end of the reporting period and makes allowance for obsolete and slowmoving inventory items identified that are • no longer suitable for use in production or sale. The management estimates the net realisable value for such finished goods and raw materials based primarily on the latest selling and purchase prices and current market conditions. The Group carries out an inventory review on a product-by-product basis at the end of the reporting period and makes allowance for obsolete items.

### How our audit addressed the key audit matter

Our audit procedures to assess the valuation of inventories included the following:

- Obtaining an understanding of how allowance for inventories is estimated by the management;
- Testing the ageing analysis of inventory, on a sample basis, to goods receipt notes;
- Discussing with the management and evaluating the basis of obsolete inventories identified by the management, based on the current market conditions, product life cycle and marketing and promotion plans;
- Assessing the reasonableness of allowance for inventories with reference to historical sales records, current market conditions, product life cycle, ageing analysis and subsequent selling and purchase prices of the inventories; and
- Tracing a selection of inventories with subsequent selling prices to sales invoices.

#### Key audit matter

#### Valuation of investment properties

We identified the valuation of investment properties as a key audit matter because of the significant judgements are required to determine the fair value of investment properties.

As disclosed in note 15 to the consolidated financial statements, the Group's investment properties amounted to HK\$384,949,000 as at 31 December 2017. Gain on changes in fair value of investment properties of HK\$9,565,000 was recognised in the consolidated statement of profit or loss and other comprehensive income for the year then ended.

The fair value of the Group's investment properties was determined by adopting the valuation techniques with significant unobservable inputs, assumptions of market conditions and judgements based on the valuation performed by independent qualified professional valuers. Details of the valuation techniques and key inputs used in the valuations are disclosed in note 15 in the consolidated financial statements.

### How our audit addressed the key audit matter

Our audit procedures to assess the valuation of investment properties included the following:

- Obtaining the valuation report from independent qualified professional valuers and discussing with management and independent qualified valuers to understand the valuation basis, methodology used and underlying assumptions applied;
- Evaluating management's process in respect of reviewing the valuation performed by independent qualified professional valuers;
- Evaluating the competence, capabilities and objectivity of independent qualified professional valuers;
- Challenging the valuation techniques and reasonableness of the significant inputs adopted by the management of the Group and the independent qualified professional valuers based on our knowledge of the property industry;
- Performing market research and analysis to assess whether the changes in fair value of investment properties resulted from the valuation was reasonable and consistent with market trends to our knowledge.

#### 1. GENERAL INFORMATION

The Company was incorporated in Bermuda as an exempted company under the Companies Act 1981 of Bermuda (as amended) with limited liability. The addresses of the registered office and principal place of business of the Company are disclosed in the corporate information section of the annual report.

The functional currency of the Company is Renminbi ("RMB"). The consolidated financial statements are presented in Hong Kong dollars ("HK\$"), as the Directors consider that it is a more appropriate presentation for a company listed on The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and for the convenience of the shareholders.

The Company is an investment holding company. The principal activities of its subsidiaries are disclosed in note 42.

Debt instruments that are held within a business model whose objective is achieved both by collecting contractual cash flows and selling financial assets, and that have contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding, are measured at fair value through other comprehensive income ("FVTOCI"). All other financial assets are measured at their fair value at subsequent accounting periods. In addition, under IFRS 9, entities may make an irrevocable election to present subsequent changes in the fair value of an equity investment (that is not held for trading) in other comprehensive income, with only dividend income generally recognised in profit or loss.
- In relation to the impairment of financial assets, IFRS 9 requires an expected credit loss model, as opposed to an incurred credit loss model under IAS 39. The expected credit loss model requires an entity to account for expected credit losses and changes in those expected credit losses at each reporting date to reflect changes in credit risk since initial recognition. In other words, it is no longer necessary for a credit event to have occurred before credit losses are recognised.

#### Classification and measurement:

Debt instruments classified as loan receivables carried at amortised cost: these are held within a business model whose objective is to collect the contractual cash flows that are solely payments of principal and interest on the principal outstanding. Accordingly, these financial assets will continue to be subsequently measured at amortised cost upon the application of IFRS 9;

Listed equity securities classified as available-for-sale investments carried at fair value: these securities qualified for designation as measured at FVTOCI under IFRS 9 and the Directors have elected to present subsequent changes in fair value in other comprehensive income, however, the fair value gains or losses accumulated in the assets revaluation reserve amounting to HK\$47,534,000 as at 1 January 2018 will no longer be subsequently reclassified to profit or loss under IFRS 9, which is different from the current treatment. This will affect the amounts recognised in the Group's profit or loss and other comprehensive income but will not affect total comprehensive income;

All other financial assets and financial liabilities will continue to be measured on the same bases as are currently measured under IAS 39.

#### *Impairment*

In general, the Directors of the Company anticipate that the application of the expected credit loss model of IFRS 9 will result in earlier provision of credit losses which are not yet incurred in relation to the Group's financial assets measured at amortised costs and other items that subject to the impairment provisions upon application of IFRS 9 by the Group.

Based on the assessment by the Directors of the Company, if the expected credit loss model were to be applied by the Group, the accumulated amount of impairment loss to be recognised by the Group as at 1 January 2018 would be increased as compared to the accumulated amount recognised under IAS 39 mainly attributable to expected credit losses provision on trade receivables. Such further impairment recognised under expected credit loss model would reduce the opening accumulated profits at 1 January 2018.

#### IFRS 15 "Revenue from contracts with customers"

IFRS 15 was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. IFRS 15 will supersede the current revenue recognition guidance including IAS 18 "Revenue", IAS 11 "Construction contracts" and the related Interpretations when it becomes effective.

#### 減值

# IFRS 15 "Revenue from contracts with customers" (CONTINUED)

The core principle of IFRS 15 is that an entity should recognise revenue to depict the transfer of promised goods or services to customers in an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services. Specifically, the standard introduces a 5-step approach to revenue recognition:

- Step 1: Identify the contract(s) with a customer
- Step 2: Identify the performance obligations in the contract
- Step 3: Determine the transaction price
- Step 4: Allocate the transaction price to the performance obligations in the contract
- Step 5: Recognise revenue when (or as) the entity satisfies a performance obligation

Under IFRS 15, an entity recognises revenue when (or as) a performance obligation is satisfied, i.e. when 'control' of the goods or services underlying the particular performance obligation is transferred to the customer. Far more prescriptive guidance has been added in IFRS 15 to deal with specific scenarios. Furthermore, extensive disclosures are required by IFRS 15.

In 2016, Clarifications to IFRS 15 in relation to the identification of performance obligations, principal versus agent considerations, as well as licensing application guidance has been issued.

國際財務報告準則第15號之核心原則為實體所確認描述向客戶轉讓承諾貨品或服務之收益金額,應為能反映該實體預期就交換該等貨品或服務有權獲得之代價。具體而言,該準則引入確認收益的五個步驟:

- 第二步:識別合約中之履約責任
- 第三步: 釐定交易價

根據國際財務報告準則第15號,實體於完成履約責任時(或就此)確認收益,即於特定履約責任相關之商品或服務的「控制權」轉讓予客戶時。國際財務報告準則15號已就特別情況之處理方法加入更明確之指引。此外,國際財務報告準則第15號要求更詳盡之披露。

於二零一六年,已頒佈國際財務報告準則第15 號有關確定履約義務、委託人與代理安排及發 牌申請指引之澄清。

The Directors anticipate that the application of IFRS 15 in the future may result in more disclosures in the consolidated financial statements, however, the Directors of the Company do not anticipate that the application of IFRS 15 will have a material impact on the timing and amounts of revenue recognised in the respective reporting periods.

#### IFRS 16 "Leases"

IFRS 16 introduces a comprehensive model for the identification of lease arrangements and accounting treatments for both lessors and lessees. IFRS 16 will supersede IAS 17 "Leases" and the related interpretations when it becomes effective.

IFRS 16 distinguishes lease and service contracts on the basis of whether an identified assets is controlled by a customer. Distinctions of operating leases and finance leases are removed for lease accounting, and is replaced a single model where a right-of-use asset and a corresponding liability have to be recognised for all leases by lessees, except for short-term leases and leases of low value assets.

The right-of-use asset is initially measured at cost and subsequently measured at cost (subject to certain exceptions) less accumulated depreciation and impairment losses, adjusted for any remeasurement of the lease liability. The lease liability is initially measured at the present value of the lease payments that are not paid at that date. Subsequently, the lease liability is adjusted for interest and lease payments, as well as the impact of lease modifications, amongst others. For the classification of cash flows, the Group currently presents upfront prepaid lease payments as investing cash flows in relation to investment properties while other operating lease payments are presented as operating cash flows. Upon application of IFRS 16, lease payments in relation to lease liability will be allocated into a principal and an interest portion which will be presented as financing cash flows by the Group.

Under IAS 17, the Group has already recognised prepaid lease payments for leasehold lands where the group is a lessee. The application of IFRS 16 may result in potential changes in classification of these assets depending on whether the Group presents right-of-use assets separately or within the same line item at which the corresponding underlying assets would be presented if they were owned.

In contrast to lessee accounting, IFRS 16 substantially carries forward the lessor accounting requirements in IAS 17, and continues to require a lessor to classify a lease either as an operating lease or a finance lease.

Furthermore, extensive disclosures are required by IFRS 16.

#### IFRS 16 "Leases" (CONTINUED)

As at 31 December 2017, the Group has non-cancellable operating lease commitment of HK\$13,061,000 as disclosed in note 33. A preliminary assessment indicates that these arrangements will meet the definition of a lease. Upon application of IFRS 16, the Group will recognise a right-ofuse asset and a corresponding liability in respect of all these leases unless they qualify for low value or short-term leases. In addition, the Group currently considers refundable rental deposits paid and refundable rental deposits received as rights and obligations under leases to which IAS 17 applies. Based on the definition of lease payments under IFRS 16, such deposits are not payments relating to the right to use the underlying assets, accordingly, the carrying amounts of such deposits may be adjusted to amortised cost and such adjustments are considered as additional lease payments. Adjustments to refundable rental deposits paid would be included in the carrying amount of right-of-use assets. Adjustments to refundable rental deposits received would be considered as advance lease payments.

Furthermore, the application of new requirements may result in changes in measurement, presentation and disclosure as indicated above.

# Amendments to IFRS 10 and IAS 28 "Sale or contribution of assets between an investor and its associate or joint venture"

The amendments to IFRS 10 "Consolidated financial statements" and IAS 28 "Investments in associates and joint ventures" deal with situations where there is a sale or contribution of assets between an investor and its associate or joint venture. Specifically, the amendments state that gains or losses resulting from the loss of control of a subsidiary that does not contain a business in a transaction with an associate or a joint venture that is accounted for using the equity method, are recognised in the parent's profit or loss only to the extent of the unrelated investors' interests in that associate or joint venture. Similarly, gains and losses resulting from the remeasurement of investments retained in any former subsidiary (that has become an associate or a joint venture that is accounted for using the equity method) to fair value are recognised in the former parent's profit or loss only to the extent of the unrelated investors' interests in the new associate or joint venture.

The Directors anticipate that the application of these amendments to IFRS 10 and IAS 28 may have an impact on the Group's consolidated financial statements in future periods should such transactions arise.

#### Amendments to IAS 40 "Transfers of investment property"

The amendments clarify that a transfer to, or from, investment property necessitates an assessment of whether a property meets, or has ceased to meet, the definition of investment property, supported by observable evidence that a change in use has occurred. The amendments further clarify that situations other than the ones listed in IAS 40 may evidence a change in use, and that a change in use is possible for properties under construction. For example, change in use for transfer from properties under development for sale in the ordinary course of business to investment properties could be evidenced by inception of an operating lease to another party. Currently, the Group accounts for such transfer only upon commencement of an operating lease.

The Directors of the Company anticipate that the application of these amendments will result in early recognition of such transfers on the Group's consolidated financial statements in future periods should there be a change in use of any of its properties.



The consolidated financial statements have been prepared on the historical cost basis except for certain properties and financial instruments that are measured at fair values at the end of each reporting periods as explained in the accounting policies set out below.

Historical cost is generally based on the fair value of the consideration given in exchange for goods and services.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of whether that price is directly observable or estimated using another valuation technique. In estimating the fair value of an asset or a liability, the Group takes into account the characteristics of the asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement date. Fair value for measurement and/or disclosure purposes in these consolidated financial statements is determined on such a basis, except for share-based payment transactions that are within the scope of IFRS 2 "Share-based payment", leasing transactions that are within the scope of IAS 17 "Leases", and measurements that have some similarities to fair value but are not fair value, such as net realisable value in IAS 2 "Inventories" or value in use in IAS 36 "Impairment of

A fair value measurement of a non-financial asset takes into account a market participant's ability to generate economic benefits by using the asset in its highest and best use by selling it to another market participant that would use the asset in its highest and best use.

The principal accounting policies are set out below.

#### Basis of consolidation

The consolidated financial statements incorporate the financial statements of the Company and entities controlled by the Company and its subsidiaries. Control is achieved when the Company:

- has power over the investee;
- has exposure, or rights, to variable returns from its involvement with the investee; and
- has the ability to use its power over the investee to affect its returns.

The Group reassesses whether or not it controls an investee if facts and circumstances indicate that there are changes to one or more of the three elements of control listed above.

#### Basis of consolidation (CONTINUED)

Consolidation of a subsidiary begins when the Group obtains control over the subsidiary and ceases when the Group loses control of the subsidiary. Specifically, income and expenses of a subsidiary acquired or disposed of during the year are included in the consolidated statement of profit or loss from the date the Group gains control until the date when the Group ceases to control the subsidiary.

Profit or loss and each item of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests. Total comprehensive income of subsidiaries is attributed to the owners of the Company and to the non-controlling interests even if this results in the non-controlling interests having a deficit balance.

Where necessary, adjustments are made to the financial statements of subsidiaries to bring their accounting policies in line with those used by other members of the Group's accounting policies.

All intra-group assets and liabilities, equity, income, expenses and cash flows relating to transactions between members of the Group are eliminated in full on consolidation.

## Changes in the Group's ownership interests in existing subsidiaries

Changes in the Group's ownership interests in existing subsidiaries that do not result in the Group losing control over the subsidiaries are accounted for as equity transactions. The carrying amounts of the Group's relevant components of equity and the non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiaries, including re-attribution of relevant reserves between the Group and the non-controlling interests according to the Group's and the non-controlling interests' proportionate interests. Any difference between the amount by which the non-controlling interests are adjusted, and the fair value of the consideration paid or received is recognised directly in equity and attributed to owners of the Company.

## Changes in the Group's ownership interests in existing subsidiaries (CONTINUED)

When the Group loses control of a subsidiary, the assets and liabilities of that subsidiary and non-controlling interests (if any) are derecognised. A gain or loss is recognised in profit or loss and is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest and (ii) the previous carrying amount of the assets (including goodwill), and liabilities of the subsidiary attributable to the owners of the Company and any non-controlling interests. All amounts previously recognised in other comprehensive income in relation to that subsidiary are accounted for as if the Group had directly disposed of the related assets or liabilities of the subsidiary (i.e. reclassified to profit or loss or transferred to another category of equity as specified/permitted by applicable IFRSs).

#### Interests in associates

An associate is an entity over which the Group has significant influence. Significant influence is the power to participate in the financial and operating policy decisions of the investee but is not control or joint control over those policies.

The results and assets and liabilities of associates are incorporated in these consolidated financial statements using the equity method of accounting except when the investment is classified as held for sale, in which case it is account for in accordance with IFRS 5 "Non-current assets held for sale and discontinued operations." The financial statements of associates used for equity accounting purposes are prepared using uniform accounting policies as those of the Group for like transactions and events in similar circumstances. Under the equity method, an investment in an associate is initially recognised in the consolidated statement of financial position at cost and adjusted thereafter to recognise the Group's share of the profit or loss and other comprehensive income of the associate. When the Group's share of losses of an associate exceeds the Group's interest in that associate (which includes any long-term interests that, in substance, form part of the Group's net investment in the associate), the Group discontinues recognising its share of further losses. Additional losses are recognised only to the extent that the Group has incurred legal or constructive obligations or made payments on behalf of the associate.

#### 於聯營公司之權益

#### Interests in associates (CONTINUED)

An investment in an associate is accounted for using the equity method from the date of which the investee becomes an associate. On acquisition of the investment in an associate, any excess of the cost of the investment over the Group's share of the net fair value of the identifiable assets and liabilities of the investee is recognised as goodwill, which is included within the carrying amount of the investment. Any excess of the Group's share of the net fair value of the identifiable assets and liabilities over the cost of the investment, after reassessment, is recognised immediately in profit or loss in the period in which the investment is acquired.

The requirements of IAS 39 are applied to determine whether it is necessary to recognise any impairment loss with respect to the Group's investment in an associate. When necessary, the entire carrying amount of the investment (including goodwill) is tested for impairment in accordance with IAS 36 "Impairment of assets" as a single asset by comparing its recoverable amount (higher of value in use and fair value less costs to sell) with its carrying amount. Any impairment loss recognised forms part of the carrying amount of the investment. Any reversal of that impairment loss is recognised in accordance with IAS 36 to the extent that the recoverable amount of the investment subsequently increases.

The Group discontinues the use of the equity method from the date when the investment is classified as held for sale.

When the Group ceases to have significant influence over an associate or joint control over a joint venture, it is accounted for as a disposal of the entire interest in the investee with a resulting gain or loss being recognised in profit or loss. In addition, the Group accounts for all amounts previously recognised in other comprehensive income in relation to that associate on the same basis as would be required if that associate had directly disposed of the related assets or liabilities. Therefore, if a gain or loss previously recognised in other comprehensive income by that associate would be reclassified to profit or loss on the disposal of the related assets or liabilities, the Group reclassifies the gain or loss from equity to profit or loss (as a reclassification adjustment) upon disposal of the relevant associate.

於一間聯營公司之投資由被投資公司成為一間聯營公司之日起,以權益會計法入賬。在收購於一間聯營公司之投資時,收購成本超出本集團分佔被投資公司可識別資產及負債公平值淨值之部分會確認為商譽,並計入該投資之賬面值中。經重新評估後,本集團分佔可識別資產及負債之公平值淨值超出投資成本之部分,即時於收購投資之期間之損益中確認。

國際會計準則第39號之規定乃用以釐定是否需要就本集團於一間聯營公司之投資確認任何減值虧損。如需要時,該項投資之全部賬面值(包括商譽)會根據國際會計準則第36號「資產減值」以單一項資產的方式進行減值測試,方法是比較其可收回金額(即使用價值與公平值減出售成本之較高者)與賬面值。任何已確認之減值虧損構成該項投資賬面值之一部份。有關減值虧損之任何撥回乃根據國際會計準則第36號確認,惟以該項投資其後增加之可收回金額為限。

本集團自投資被分類為持作代售資產時終止採 用權益法。

當本集團對一間聯營公司不再具有重大影響力或不再擁有一間合營企業之共同控制權時,則列作出售投資對象之全部權益入賬,而所得盈虧於損益內確認。此外,本集團會將先前就該聯營公司在其他全面收益確認之所有金額入賬,基準與該聯營公司直接出售相關資產或負債所需基準相同。因此,倘若該聯營公司先前已於其他全面收益確認之盈虧會於出售相關資產或負債時重新分類至損益,本集團會於出售相關聯營公司時將盈虧由權益重新分類至損益(作為重新分類調整)。

#### Non-current assets held for sale

Non-current assets and disposal groups are classified as held for sale if their carrying amount will be recovered principally through a sale transaction rather than through continuing use. This condition is regarded as met only when the asset (or disposal group) is available for immediate sale in its present condition subject only to terms that are usual and customary for sales of such asset (or disposal group) and its sale is highly probable. Management must be committed to the sale, which should be expected to qualify for recognition as a completed sale within one year from the date of classification.

When the Group is committed to a sale plan involving disposal of an investment in an associate, the investment that will be disposed of is classified as held for sale when the criteria described above are met, and the Group discontinues the use of the equity method in relation to the portion that is classified as held for sale. The Group discontinues the use of the equity method at the time of disposal when the disposal results in the Group losing significant influence over the associate.

Non-current assets classified as held for sale are measured at the lower of their previous carrying amount and fair value less costs to sell.

#### Revenue recognition

Revenue is measured at the fair value of the consideration received or receivable. Revenue is reduced for discounts and sales related taxes.

Revenue is recognised when the amount of revenue can be reliably measured; when it is probable that future economic benefits will flow to the Group and when specific criteria have been met for each of the Group's activities, as described below.

Revenue from the sale of goods is recognised when the goods are delivered and titles have passed.

Revenue from sale of properties in the ordinary course of business is recognised when the respective properties have been completed and delivered to the buyers. Deposits and instalments received from purchasers prior to meeting to meeting the above criteria for revenue recognition are included in the consolidated statement of financial position under current liabilities.


#### 收入確認

收入按已收或應收取代價的公平值計量,並已 扣除折扣及銷售有關稅項。

收益於收益金額能可靠地計量時;未來經濟利 益將有可能流入本集團時;及本集團各業務活 動達致特定條件時確認,詳情參見下文。

銷售貨品的收益於貨品交付及擁有權轉移時確認。

於日常業務過程中銷售物業所得的收入,於相關物業已竣工及交付予買方時確認。於達致上述收益確認條件前所收取之按金及分期款項計入綜合財務狀況報表流動負債項下。

#### Revenue recognition (CONTINUED)

Service income is recognised when services are provided.

Dividend income from investments is recognised when the rights to receive payment have been established.

Interest income from a financial asset is accrued on a time basis, by reference to the principal outstanding and at the effective interest rate applicable, which is the rate that exactly discounts the estimated future cash receipts through the expected life of the financial asset to that asset's net carrying amount on initial recognition.

The Group's accounting policy for recognition of revenue from operating leases is described in the accounting policy for leasing below.

#### Foreign currencies

In preparing the financial statements of each individual group entity, transactions in currencies other than the functional currency of that entity (foreign currencies) are recognised at the rates of exchanges prevailing on the dates of the transactions. At the end of the reporting period, monetary items denominated in foreign currencies are retranslated at the rates prevailing at that date.

Exchange differences arising on the settlement of monetary items, and on the retranslation of monetary items, are recognised in profit of loss in the period in which they arise.

For the purposes of presenting the consolidated financial statements, the assets and liabilities of the Group's entities are translated into the presentation currency of the Group (i.e. HK\$) at the rate of exchange prevailing at the end of the reporting period, and their income and expenses are translated at the average exchange rates for the year. Exchange differences arising are recognised in other comprehensive income and accumulated in equity under the heading of the translation reserve (attributed to noncontrolling interests as appropriate).

#### 收入確認(續)

服務收入於提供服務時確認。

投資股息收入於收取款項之權利成立時確認。

金融資產之利息收入乃考慮未提取之本金額及 所適用之實際利率按時間基準確認入賬,該利 率指於初始確認時金融資產之估計未來所收現 金在估計可使用期內折現至該資產賬面淨值之 利率。

本集團確認經營租賃產生之收益的會計政策於 下列經營租賃的會計政策中描述。

#### 外幣

於編製每間個別集團實體的財務報表時,倘交 易的貨幣與實體的功能貨幣(外幣)不同,則按 交易日期適用的匯率確認。於報告期末,以外 幣為面值的貨幣項目按該日適用的匯率重新換 算。

結算貨幣項目及重新換算貨幣項目所產生的匯 率差異,於其產生期間在損益賬內確認。

為呈列綜合財務報表的目的,本集團實體的資產及負債均以報告期末適用匯率換算為本集團的呈列貨幣(即港元),而其收入及開支則以本年度平均匯率予以換算。產生的匯率差異於其他全面收益確認及累計於權益的換算儲備項下(倘適合將分配予非控股權益)。

#### **Taxation**

Income tax expense represents the sum of the tax currently payable and deferred tax.

The tax currently payable is based on taxable profit for the year. Taxable profit differs from profit as reported in the profit or loss because it excludes items of income or expense that are taxable or deductible in other years and it further excludes items that are never taxable and deductible. The Group's liability for current tax is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is recognised on temporary differences between the carrying amounts of assets and liabilities in the consolidated financial statements and the corresponding tax base used in the computation of taxable profit. Deferred tax liabilities are generally recognised for all taxable temporary differences. Deferred tax assets are generally recognised for all deductible temporary difference to the extent that it is probable that taxable profits will be available against which those deductible temporary differences can be utilised. Such assets and liabilities are not recognised if the temporary difference arises from goodwill or from the initial recognition (other than in a business combination) of other assets and liabilities in a transaction that affects neither the taxable profit nor the accounting profit.

Deferred tax liabilities are recognised for taxable temporary differences associated with investments in subsidiaries and associates, except where the Group is able to control the reversal of the temporary difference and it is probable that the temporary difference will not reverse in the foreseeable future. Deferred tax assets arising from deductible temporary differences associated with such investments are only recognised to the extent that it is probable that there will be sufficient taxable profits against which to utilise the benefits of the temporary differences and they are expected to reverse in the foreseeable future.

#### 税項

所得税開支指現時應付税項及遞延税項之總 和。

現時應付税項乃按本年應課税溢利計算。應課 税溢利不包括其他年度的應課税或應扣減之收 入或開支項目,亦不包括從未課税或可扣税之 項目,故與損益表所列溢利不同。本集團本期 税項負債乃按已於報告期末實施或大致實施之 税率計算。

遞延税項以綜合財務報表內資產及負債賬面值 與計算應課税溢利所採用相應税基之暫時差異 入賬。遞延税項負債通常會就所有可抵減暫時 差額確認,惟在應課税溢利可供可扣減暫時差 額抵銷時,方就所有可扣減暫時差額確認遞延 税項資產。倘若暫時差額由商譽或由初次確認 一項不影響應課税溢利或會計溢利之其他資產 及負債(業務合併除外)所產生,則不會確認有 關資產及負債。

遞延税項負債乃按於附屬公司及聯營公司之投資而引致之應課税暫時差額而確認,惟若本集團可控制暫時差額之撥回及暫時差額有可能不會於可見將來之撥回之情況則除外。與該等投資相關的可扣減暫時差額所產生的遞延税項資產,僅在按可能出現可利用暫時差額扣税之應課稅溢利時,並預期於可見將來撥回時,方會進行確認。

#### Taxation (CONTINUED)

The carrying amount of deferred tax assets is reviewed at the end of the reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow all or part of the asset to be recovered.

Deferred tax assets and liabilities are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset is realised, based on tax rate (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The measurement of deferred tax liabilities and assets reflects the tax consequences that would follow from the manner in which the Group expects, at the end of the reporting period, to recover or settle the carrying amount of its assets and liabilities.

For the purposes of measuring deferred tax for investment properties that are measured using the fair value model, the carrying amounts of such properties are presumed to be recovered entirely through sale, unless the presumption is rebutted. The presumption is rebutted when the investment property is depreciable and is held within a business model whose objective is to consume substantially all of the economic benefits embodied in the investment property over time, rather than through sale.

Current and deferred tax is recognised in profit or loss, except when it relates to items that are recognised in other comprehensive income or directly in equity, in which case the current and deferred tax is also recognised in other comprehensive income or directly in equity respectively.

#### 税項(續)

遞延税項資產之賬面值於各報告期末作檢討, 並在沒可能會有足夠應課税溢利收回全部或部 分資產時加以遞減。

根據報告期末已頒佈或實際已頒佈之税率(及 税法),遞延税項資產及負債按負債清償或資 產變現期間預期適用之税率計量。

遞延税項負債及資產之計量反映本集團預期於 報告期末將出現的稅務後果,以收回資產或清 償負債之賬面值。

就計算使用公平值模式計量之投資物業之遞延 税項而言,該等物業之賬面值乃假設透過出售 而收回,除非有關假設被推翻。倘投資物業乃 可予折舊,且持有投資物業之業務模式隨時間 (而非透過出售)消耗投資物業大部分內在經濟 利益,則有關假設會被推翻。

本期及遞延税項於損益確認,惟當其與於其他 全面收益確認或直接於權益確認之項目有關 時,在此情況下,本期及遞延税項亦會分別於 其他全面收益確認或直接於權益確認。

#### Leasing

Leases are classified as finance leases whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee. All other leases are classified as operating leases.

#### The Group as lessor

Amounts due from lessees under finance leases are recognised as receivables at the amount of the Group's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the Group's net investment outstanding in respect of the leases.

Rental income from operating leases is recognised on a straight-line basis over the term of the relevant lease. Initial direct costs incurred in negotiating and arranging an operating lease are added to the carrying amount of the leased asset and recognised on a straight-line basis over the lease term.

#### The Group as lessee

Operating lease payments, including the cost of acquiring land held under operating leases, are recognised as an expense on a straight-line basis over the lease term, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

In the event that lease incentives are received to enter into operating leases, such incentives are recognised as a liability. The aggregate benefit of incentives is recognised as a reduction of rental expense on a straight-line basis, except where another systematic basis is more representative of the time pattern in which economic benefits from the leased asset are consumed.

#### 租約

當租約條款將涉及擁有權之絕大部分風險及回 報轉讓予承租人時,該租約乃分類為融資租 約。所有其他租約均分類為經營租約。

#### 由本集團出租


根據融資租賃應收承租人的款項會按本集團於租賃的淨投資金額確認為應收款項。融資租賃 收入被分配至會計期間,以反映本集團於有關租賃的未償還淨投資的定期回報率。

經營租約之租金收入乃按相關租約年期以直線 法在損益內確認。磋商及安排經營租賃所產生 之初始直接成本計入該項租賃資產之脹面值, 並於租期內以直線法確認。

#### 由本集團承租

經營租約付款(包括收購經營租賃持有土地之成本)以直線法於租約期內確認為開支,惟倘另一種系統基準更能反映租賃資產消耗經濟利益的時間模式除外。

如訂立經營租時收取租賃優惠,該優惠確認為 負債。優惠之利益總額按直線基準確認為租金 開支的減少,惟倘另一種系統基準更能反映租 賃資產消耗經濟利益的時間模式除外。

#### **Government grants**

Government grants are not recognised until there is reasonable assurance that the Group will comply with the conditions attaching to them and that the grants will be received.

Government grants are recognised in profit or loss on a systematic basis over the periods in which the Group recognises as expenses the related costs for which the grants are intended to compensate. Specifically, government grants where primary condition is that the Group should purchase, construct or otherwise acquire non-current assets are recognised as deferred income in the consolidated statement of financial position and transferred to profit or loss over the useful lives of the related assets.

Government grants that are receivable as compensation for expenses or losses already incurred or for the purpose of giving immediate financial support to the Group with no future related costs are recognised in profit or loss on a systematic and rational basis in the period in which they become receivable.

#### Retirement benefit costs

Payments to state-managed retirement benefits schemes and the Mandatory Provident Fund Scheme ("MPF Scheme") are recognised as an expense when employees have rendered service entitling them to the contributions.

#### Short-term employee benefits

Short-term employee benefits are recognised at the undiscounted amount of the benefits expected to be paid as and when employees rendered the services. All short-term employee benefits are recognised as an expense unless another IFRS requires or permits the inclusion of the benefit in the cost of an asset.

A liability is recognised for benefits accruing to employees (such as wages and salaries, annual leave and sick leave) after deducting any amount already paid.

#### 政府項目收入

在合理地保證本集團會遵守政府項目收入的附 帶條件以及將會得到補助後,政府項目收入方 會予以確認。

政府項目收入按本集團將擬用作補償的補貼相關成本確認為開支的期間有系統地於損益確認。具體而言,主要條件為本集團應購買、建造或以其他方式購入非流動資產的政府項目收入於綜合財務狀況表中確認為遞延收入,並按有關資產的可用年期轉撥至損益。

作為本集團已發生的費用或損失的補償,或是 為本集團提供直接財務支援而未來不會發生任 何相關成本的應收政府項目收入,在其成為應 收款項的期間有系統及合理地於損益確認。

#### 退休福利成本

向國家管理之退休福利計劃及強制公積金計劃 (「強積金計劃」)支付之款項於僱員提供服務而 有權獲得供款時確認為開支。

#### 短期僱員福利

短期僱員福利於僱員提供服務時按預計將支付 福利的未貼現金額確認。所有短期僱員福利確 認為開支,除非另一項國際財務報告準則要求 或允許將有關福利納入資產成本。

在扣除已支付之任何款項後,對僱員應得的福 利(如工資及薪金、年假及病假)確認為負債。

#### Investment properties

Investment properties are properties held to earn rentals and/ or for capital appreciation.

Investment properties are initially measured at cost, including any directly attributable expenditure, except for those transferred from property, plant and equipment and land use rights which are measured at fair value at date of transferred. Subsequent to initial recognition, investment properties are measured at their fair value using the fair value model. Gains or losses arising from changes in the fair value of investment property are included in profit or loss for the period in which they arise.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use or no future economic benefits are expected from its disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the profit or loss in the period in which the item is derecognised.

#### Property, plant and equipment

Property, plant and equipment including buildings held for use in the production or supply of goods or services, are stated in the consolidated statement of financial position at cost less subsequent accumulated depreciation and subsequent accumulated impairment losses.

Depreciation is recognised so as to write off the cost of assets less their residual values over their estimated useful lives, using the straight-line method. The estimated useful lives, residual values and depreciation method are reviewed at the end of each reporting period, with the effect of any changes in estimate accounted for on a prospective basis.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on the disposal or retirement of an item of property, plant and equipment is determined as the difference between sales proceeds and the carrying amount of the asset and is recognised in profit or loss.

#### 投資物業

投資物業是指持作賺取租金及/或資本增值的 物業。

投資物業除由物業、廠房及設備及土地使用轉 撥而於轉撥之日用公平值量度,均於首次確認 時按成本(包括任何相關的直接支出)計量。於 首次確認後,投資物業是採用公平值模式以其 公平值計量。投資物業的公平值變動所產生的 收益或虧損於產生期間直接確認為損益。

當投資物業出售,或永久不再被使用,或預期 出售不會產生未來經濟利益時,該項投資物業 不再被確認。因不再確認為資產而產生的收益 或虧損(按出售所得款項淨額與資產的賬面值 之差額計算)於該項目取消確認期間在損益內 入賬。

#### 物業、廠房及設備

物業、廠房及設備(包括持作生產或提供貨物 或服務的建築物)按成本減其後累計折舊以及 其後累計減值虧損,於綜合財務狀況表列賬。

折舊採用直線法,按資產減去其剩餘價值後在估計可使用年期撇減其成本。估計可使用年期、剩餘價值和折舊方法在每個報告期間結束時檢討,並採用未來基準計算估計變更的影響。

物業、廠房及設備項目於出售或預期持續使用該資產後亦將不會產生任何日後經濟利益之時,取消確認。物業、廠房及設備項目出售或報廢時所產生的任何收益或虧損按出售所得款項與該資產賬面值之間的差額釐定並確認為利潤或虧損。

#### Leasehold land and building

When the Group makes payments for a property interest which includes both leasehold land and building elements, the Group assesses the classification of each element separately based on the assessment as to whether substantially all the risks and rewards incidental to ownership of each element have been transferred to the Group, unless it is clear that both elements are operating leases in which case the entire property is accounted as an operating lease. Specifically, the entire consideration (including any lump-sum upfront payments) are allocated between the leasehold land and the building elements in proportion to the relative fair values of the leasehold interests in the land element and building element at initial recognition.

To the extent the allocation of the relevant payments can be made reliably, interest in leasehold land that is accounted for as an operating lease is presented as "prepaid lease payments" in the consolidated statement of financial position and is amortised over the lease term on a straight-line basis except for those that are classified and accounted for as investment properties under the fair value model. When the payments cannot be allocated reliably between the leasehold land and building elements, the entire property is generally classified as if the leasehold land is under finance lease.

#### **Borrowing costs**

Borrowing costs directly attributable to the acquisition, construction or production of qualifying assets, which are assets that necessarily take a substantial period of time to get ready for their intended use or sale, are added to the cost of those assets until such time as the assets are substantially ready for their intended use or sale. Investment income earned on the temporary investment of specific borrowings pending their expenditure on qualifying assets is deducted from the borrowing costs eligible for capitalisation.

All other borrowing costs are recognised in profit or loss in the period in which they are incurred.

#### 租賃土地及樓宇

當本集團支付一份同時包括租賃土地及樓宇部分之物業權益時,本集團會分別依照各部分擁有權隨附之絕大部分風險及回報是否已轉移至本集團作評估,除非兩個部分清楚確認為經營租賃,於此情況下,整體物業列作經營租賃入賬。具體而言,所有代價(包括任何一筆過支付的預付款項)會按初始確認時租賃土地部分與樓宇部分租賃權益的相關公平值比例,於租賃土地與樓宇部分之間分配。

在相關租金能可靠分配的情況下,經營租賃的租賃土地權益應於綜合財務狀況表中呈列為「預付租金」,並按直線基準在租賃期間攤銷,除非其獲分類為並按公平值模式列作投資物業入賬。當租金不能夠在租賃土地與樓宇部分間可靠地分配時,整體物業通常被分類為融資租賃項下之租賃土地。

#### 借貸成本

與收購、建造或生產合資格資產直接有關之借 貸成本均撥充資本,作為該等資產之部分成 本。當資產大致可作其擬定用途或可供銷售 時,該等借貸成本將不再撥充為資本。特定借 貸中,在其應用於合資格的資產之前所作的臨 時投資所賺取的投資收入,須於資本化的借貸 成本中扣除。

所有其他借貸成本均在發生期間於損益內確 認。

#### Intangible assets

#### Research and development expenditure

Expenditure on research activities is recognised as an expense in the period in which it is incurred.

An internally-generated intangible asset arising from development activities (or from the development phase of an internal project) is recognised if, and only if, all of the following have been demonstrated:

- the technical feasibility of completing the intangible asset so that it will be available for use or sale:
- the intention to complete the intangible asset and use or sell it;
- the ability to use or sell the intangible asset;
- how the intangible asset will generate probable future economic benefits;
- the availability of adequate technical, financial and other resources to complete the development and to use or sell the intangible asset; and
- the ability to measure reliably the expenditure attributable to the intangible asset during its development.

The amount initially recognised for internally-generated intangible asset is the sum of the expenditure incurred from the date when the intangible asset first meets the recognition criteria listed above. Where no internally generated intangible asset can be recognised, development expenditure is charged to profit or loss in the period in which it is incurred.

Subsequent to initial recognition, internally-generated intangible asset is measured at cost less accumulated amortisation and accumulated impairment losses, on the same basis as intangible assets acquired separately.

#### 無形資產

#### 研究及開發費用


研究活動的費用於產生之期間確認為開支。

因開發(或因內部項目的某開發階段)而於內部 產生的無形資產,會於並僅會於下列全部各項 均已展示時確認:

- 完成無形資產在技術上屬可行,其因而 將可供使用或出售:
- 有意完成無形資產並使用或出售;
- 有能力使用或出售無形資產;
- 無形資產將產生未來潛在經濟利益的方法;
- 有足夠技術、財務及其他資源完成開發並使用或出售無形資產的可使用程度;
- 有能力可靠地計量屬無形資產於開發期內的開支。

就內部產生無形資產初步確認之金額,為該等無形資產首次符合確認標準當日起產生之開支總額。倘並無內部產生無形資產可予確認,則開發費用將於產生期間內於損益內扣除。

於初次確認後,內部產生無形資產以個別購入 的無形資產的相同基準,按成本減累計攤銷及 累計減值虧損列賬。

#### Intangible assets (CONTINUED)

#### Intangible assets acquired separately

Intangible assets acquired separately and with finite useful lives are carried at costs less accumulated amortisation and any accumulated impairment losses.

Amortisation for intangible assets with finite useful lives is provided on a straight-line basis over their estimated useful lives. The estimated useful life and amortisation method are reviewed at the end of each reporting period, with the effect of any changes in estimate being accounted for on a prospective basis.

An intangible asset is derecognised on disposal, or when no future economic benefits are expected from use or disposal. Gains or losses arising from derecognition of an intangible asset are measured at the difference between the net disposal proceeds and the carrying amount of the asset and are recognised in profit or loss in the period when the asset is derecognised.

#### Impairment losses on tangible and intangible assets

At the end of the reporting period, the Group reviews the carrying amounts of its tangible and intangible assets with finite useful lives to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the relevant asset is estimated in order to determine the extent of the impairment loss, if any.

When it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the cash-generating unit to which the asset belongs. When a reasonable and consistent basis of allocation can be identified, corporate assets are also allocated to individual cash-generating units, or otherwise they are allocated to the smallest group of cash-generating units for which a reasonable and consistent allocation basis can be identified.

#### 無形資產(續)

#### 獨立購入的無形資產

獨立購入及有限定可使用年期的無形資產按成本減累計攤銷及任何累計減值虧損列賬。

可使用年期有限的無形資產於估計可使用年期 內以直線法攤銷。估計使用年期及攤銷方法於 各報告期末審閱,而估計變動之影響乃按預先 基準入賬。

無形資產於出售時或當預期使用或出售而不會產生將來經濟利益時終止確認。於終止確認無形資產時產生的任何損益,乃按該項資產的出售所得款項淨額與其賬面值之間的差額釐定,並於終止確認該項資產時之期間於損益內確認。

#### 有形及無形資產之減值虧損

於報告期末,本集團均會審閱其有限使用年期 之有形及無形資產之賬面值,以確認該等資產 是否已出現減值虧損。倘出現任何有關跡象, 則估計相關資產可收回金額,以釐定減值虧損 的幅度(如有)。

倘無法估計個別資產之可收回金額,則本集團會估計資產所屬現金產生單位之可收回金額。 倘能識別合理及一致之分配基準,公司資產亦會分配至個別現金產生單位,或(倘能確認合理及一致之分配基準)分配至最細之現金產生單位。

# Impairment losses on tangible and intangible assets (CONTINUED)

Recoverable amount is the higher of fair value less costs of disposal and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset (or a cash-generating unit) for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or a cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or a cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss.

Where an impairment loss subsequently reverses, the carrying amount of the asset (or cash-generating unit) is increased to the revised estimate of its recoverable amount, but so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset (or a cash-generating unit) in prior years. A reversal of an impairment loss is recognised immediately in profit or loss.

#### Inventories

Inventories are stated at the lower of cost and net realisable value. Cost is calculated using the weighted average method. Net realisable value represents the estimated selling price for inventories less all estimated costs of completion and costs necessary to make the sale.

#### **Provisions**

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of past event, it is probable that the Group will be required to settle that obligation, and a reliable estimate can be made of the amount of the obligation.

#### 有形及無形資產之減值虧損(續)

The amount recognised as a provision is the best estimate of the consideration required to settle the present obligation at the end of the reporting period, taking into account the risks and uncertainties surrounding the obligation. When a provision is measured using the cash flows estimated to settle the present obligation, its carrying amount is the present value of those cash flows (where the effect of the time value of money is material).

#### Properties under development for sale

Properties under development for sale are stated at lower of cost and net realisable value. Cost comprises both the land use rights and development cost of the property. Net realisable value takes into account the price ultimately expected to be realised, less applicable selling expenses and the anticipated costs to completion.

Development cost of property comprises the related land cost, construction costs, borrowing costs capitalised according to the Group's accounting policy and directly attributable costs incurred during the development period. On completion, the properties are transferred to properties held for sales.

#### Properties held for sale

Properties held for sale are stated at the lower of cost and net realisable value. Cost includes the costs of land, development expenditure incurred and, where appropriate, borrowing costs capitalised. Net realisable value is determined based on price ultimately expected to be realised less applicable selling expenses.

#### Financial instruments

Financial assets and financial liabilities are recognised on the consolidated statement of financial position when a group entity becomes a party to the contractual provisions of the instrument.

The net gain or loss recognised in profit or loss includes any dividend or interest earned on the financial assets and is included in the other gains and losses. Fair value is determined in the manner described in note 41.

Available-for-sale financial assets

Equity securities held by the Group that are classified as available-for-sale and are traded in an active market are measured at fair value at the end of each reporting period. ## Financial assets (CONTINUED)

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. Subsequent to initial recognition, loans and receivables (including amounts due from non-controlling shareholders of subsidiaries and an associate, trade and notes receivables, entrusted loan receivables, other receivables, consideration receivable, pledged bank deposits and bank balances) are carried at amortised cost using the effective interest method, less any identified impairment losses.

#### Impairment of financial assets

Financial assets, other than those at FVTPL, are assessed for indicators of impairment at the end of each reporting period. Financial assets are considered to be impaired where there is objective evidence that, as a result of one or more events that occurred after the initial recognition of the financial asset, the estimated future cash flows of the financial assets have been affected.

For an available-for-sale equity investment, a significant or prolonged decline in the fair value of that investment below its cost is considered to be objective evidence of impairment.

For loans and receivables, objective evidence of impairment could include:

- significant financial difficulty of the issuer or counterparty; or
- breach of contract, such as default or delinquency in interest and principal payments; or
- it becoming probable that the borrower will enter bankruptcy or financial re-organisation.

Objective evidence of impairment for a portfolio of receivables could include the Group's past experience of collecting payments and an increase in the number of delayed payments in the portfolio past the average credit period of 90 days.

For financial assets measured at amortised cost, if, in a subsequent period, the amount of impairment loss decreases and the decrease can be related objectively to an event occurring after the impairment loss was recognised, the previously recognised impairment loss is reversed through profit or loss to the extent that the carrying amount of the asset at the date the impairment is reversed does not exceed what the amortised cost would have been had the impairment not been recognised.

In respect of available-for-sale equity investments, impairment losses previously recognised in profit or loss are not reversed through profit or loss. Any increase in fair value subsequent to an impairment loss is recognised in other comprehensive income and accumulated under the heading of assets revaluation reserve.

Interest expense is recognised on an effective interest basis.

#### Financial liabilities at FVTPL

Financial liabilities are classified as at FVTPL when the financial liability is held for trading.

A financial liability is classified as held for trading if:

- it has been acquired principally for the purpose of repurchasing it in the near term; or
- on initial recognition it is a part of a portfolio of identified financial instruments that the Group manages together and has a recent actual pattern of short-term profittaking; or

#### Derivative financial instruments

Derivatives are initially recognised at fair value at the date when derivative contracts are entered into and are subsequently remeasured to their fair value at the end of the reporting period. The resulting gain or loss is recognised in profit or loss immediately unless the derivative is designated and effective as a hedging instrument, in which event the timing of the recognition in profit or loss depends on the nature of the hedge relationship.

#### Derecognition

The Group derecognises a financial asset only when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another entity.

The fair value of services received determined by reference to the fair value of share options granted at the grant date is expensed on a straight-line basis over the vesting period, with a corresponding increase in equity (share option reserve).

At the end of the reporting period, the Group revises its estimates of the number of options that are expected to vest based on assessment of all relevant non-market vesting conditions. The impact of the revision of the original estimates, if any, is recognised in profit or loss such that the cumulative expense reflects the revised estimate, with a corresponding adjustment to share option reserve.

At the time when the share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are forfeited after the vesting date or still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to accumulated profits.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

The following are critical judgements involving estimations, the key assumptions concerning the future, and other key sources of estimation uncertainty at the end of the reporting period, that have a significant risk of causing a material adjustment to the carrying amounts of assets and liabilities within the next financial year.

#### Allowances for inventories

The management of the Group reviews an aging analysis at the end of the reporting period and makes allowance for obsolete and slow-moving inventory items identified that are no longer suitable for use in production or sale. The management estimates the net realisable value for such finished goods and raw materials based primarily on the latest selling and purchase prices and current market conditions. The Group carries out an inventory review on a product-byproduct basis at the end of the reporting period and makes allowance for obsolete items If the market condition was to deteriorate, resulting in a lower net realisable value for such finished goods and raw materials, additional allowances may be required. As at 31 December 2017, the carrying amount of inventories is approximately HK\$758,531,000 (2016: HK\$737,417,000). During the year ended 31 December 2017, reversal of allowance of inventories of HK\$11,706,000 (2016: HK\$2,898,000) was credited to profit or loss.

#### 存貨撥備

本集團之管理層於報告期末審閱賬齡分析,並就被認定有不再適合作生產或銷售之陳舊或滯銷存貨項目作出撥備。管理層主要根據最近期買賣價格及當時之市況而估計該等製成品及原材料之可變現淨值。本集團於報告期末按產品基準進行存貨審閱及對陳舊項目作出撥備。倘若市況轉差,導致該等製成品及原材料可變現淨值下降,則可能需要作出額外撥備。於二零一七年十二月三十一日,存貨賬面值的為758,531,000港元(二零一六年:737,417,000港元)。截至二零一七年十二月三十一日止年度,存貨撥備撥回約11,706,000港元(二零一六年:2,898,000港元)已計入損益中。

#### Collectability of entrusted loan receivables

When there is objective evidence of impairment loss on entrusted loan receivables, the Group estimates the future cash flows of entrusted loan receivables for impairment testing purpose. The amount of the impairment loss is measured as the difference between the entrusted loan receivable's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate (i.e. the effective interest rate computed at initial recognition). Where the actual future cash flows are less than expected, a material impairment loss may arise in future financial periods. The aggregate carrying value of entrusted loan receivables at 31 December 2017 was HK\$36,150,000 (2016: HK\$112,700,000).

#### 應收委託貸款之可收回性

#### Impairment of trade receivables

In estimating whether allowance for bad and doubtful debts is required, the Group takes into consideration the ageing status and the likelihood of collection. When there is objective evidence of impairment loss, the Group takes into consideration the estimation of future cash flows. The amount of the impairment loss is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows (excluding future credit losses that have not been incurred) discounted at the financial asset's original effective interest rate. Where the actual future cash flows are less than expected, a material impairment loss may arise. As at 31 December 2017, the net carrying amounts of trade receivables are approximately HK\$302,581,000 (2016: HK\$234,477,000). During the year ended 31 December 2017, net reversal of allowance for bad and doubtful debts of HK\$854,000 (2016: HK\$3,324,000) is credited to profit or loss. Details of trade receivables are disclosed in note 27.

#### Estimated impairment of intangible assets

Determining whether development costs included in intangible assets are individually impaired requires an estimation of the value in use calculation by reference to the cash flow projections prepared in accordance with the signed sales contracts of respective projects. Where the actual future cash flows are less than expected, an impairment loss may arise. As at 31 December 2017, the carrying amount of development costs is approximately HK\$183,872,000 (2016: HK\$147,486,000). Details of the recoverable amount calculation of development costs are disclosed in note 19.

#### 應收貿易賬款減值

本集團於估計是否須就呆壞賬撥備時,會考慮 賬齡情況及收回的可能性。倘有客觀證據顯 示出現減值虧損,本集團會考慮未來現金流 量的估計。減值虧損金額乃按資產賬面值與 按金融資產原實際利率貼現之估計未來現值 流(不包括尚未產生之未來信貸虧損)現值間 之差額計量。倘實際未來現金流少於預期,可能會產生重大減值虧損。於二零一七年十二 月三十一日,應收貿易賬款之賬面淨值約為 302,581,000港元(二零一六年:234,477,000 港元)。截至二零一七年十二月三十一日止年 度,呆壞賬撥備撥回淨額854,000港元(二零 一六年:3,324,000港元)已計入損益。應收貿 易賬款的詳情於附註27中披露。

#### 無形資產之估計減值

於釐訂計入無形資產之開發成本是否個別出現減值時,需要估計參考根據各項目已簽訂銷售合約編製的現金流預測計算的使用價值。倘實際現金流少於預期,則會出現減值虧損。於二零一七年十二月三十一日,開發成本之賬面值約為183,872,000港元(二零一六年:147,486,000港元)。有關計算開發成本可收回金額之詳情於附註19中披露。

#### Land appreciation tax ("LAT")

The Group is subject to LAT in the PRC. However, the implementation and settlement of the tax varies amongst different tax jurisdictions in various cities of the PRC and certain projects of the Group have not yet finalised their land appreciation tax calculations and payments with any local tax authorities in the PRC. Accordingly, significant judgement is required in determining the amount of land appreciation and its related income tax provisions. The Group recognised the LAT based on management's best estimates. The final tax outcome could be different from the amounts that were initially recorded, and these differences will impact the income tax expense and the related income tax provisions in the periods in which such tax is finalised with local tax authorities.

#### Estimated fair value of investment properties

Investment properties were revalued at the end of the reporting period using income capitalisation approach by independent qualified professional valuer. Such valuation was based on certain assumptions, which are subject to uncertainty and might materially differ from the actual results. In making the valuation, the Group's management has made estimates concerning rental yield for rental income to be generated by the investment properties. The assumptions used are intended to reflect conditions existing at the end of the reporting period. Where there are any changes in the assumptions due to the market conditions in the PRC, the estimate of fair value of investment properties may be significantly affected. As at 31 December 2017, investment properties of approximately HK\$384,949,000 (2016: HK\$350,779,000) were revalued.

#### 土地增值税

本集團於中國需要繳納土地增值稅。然而,中國不同城市之稅務司法權區對稅項之落實及支付措施均有所不同,而本集團仍有若干項目未完成計算其土地增值稅金額及向中國當地稅務機關支付稅項。因此,於釐定土地增值金額及相關所得稅撥備金額時需要作出重大判斷。本集團根據管理層之最佳估算確認土地增值稅。最終稅務結果可能與初步入賬之金額有所不同,有關差異將對與當地稅務機關確定最終稅項期間之所得稅開支及相關所得稅撥備造成影響。

#### 估計投資物業之公平值

投資物業之價值會於報告期末由獨立合資格專業估值師利用收入資本化方式進行重估。有關重估乃基於若干假設進行,當中涉及不確定性,並可能與實際業績存在重大差異。在作出估值時,本集團管理層已就投資物業將產生之租金收入相關之租金收益率作出估計。所使用之假設乃為反映於報告期末出現之情況。倘有關假設因中國市場狀況出現任何變動,將可能對投資物業之估計公平值造成重大影響。於二零一七年十二月三十一日,約有384,949,000港元(二零一六年:350,779,000港元)之投資物業被重估。

#### Deferred taxation on investment properties

For the purposes of measuring deferred taxation arising from investment properties that are measured using the fair value model, the Directors of the Company have reviewed the Group's investment property portfolios and concluded that the Group's investment properties are held under a business model whose objective is to consume substantially all of the economic benefits embodied in the investment properties over time, rather than through sale. Therefore, in measuring the Group's deferred taxation on investment properties, the Directors have determined that the presumption that the carrying amounts of investment properties measured using the fair value model are recovered entirely through sale is rebutted. Accordingly, deferred taxation in relation to the Group's investment properties has been measured in accordance with the general principles set out in IAS 12.

Revenue represents the amounts received and receivable for goods sold net of discounts and sales related taxes, interest income generated from equipment financial leasing to outsiders and service income generated from service provided to outsiders.

No deferred tax asset has been recognised due to the unpredictability of future profit streams of those subsidiaries. Included in unused tax losses was HK\$129,660,000 (2016: HK\$98,871,000) that will expire by 2022 (2016: 2021). Other losses may be carried forward indefinitely.

Under the EIT Law of PRC, withholding tax is imposed on dividends declared in respect of profits earned by PRC subsidiaries from 1 January 2008 onwards. Deferred taxation has not been provided for in the consolidated financial statements in respect of temporary differences attributable to accumulated profits of the PRC subsidiaries amounting to HK\$1,127,909,000 (2016: HK\$976,399,000) as the Group is able to control the timing of the reversal of the temporary differences and it is probable that the temporary differences will not reverse in the foreseeable future.

Pursuant to the agreement, Suncom Logistics entrusted an aggregated amount of RMB30,000,000 (equivalent to approximately HK\$36,150,000) (2016: RMB30,000,000, equivalent to approximately HK\$33,810,000) to a specific corporate borrower at an interest rate of 10% per annum. Bank of Communications acted as the trustee of this entrusted loan. Trustee fee of 0.1% per month is charged. This entrusted loan will be matured in March 2018 (2016: matured in April 2017).

As at 31 December 2016, Suncom Logistics also had an entrusted loan agreement with Shanghai Pudong Development Bank. Pursuant to the agreement, Suncom Logistics entrusted an aggregated amount of RMB30,000,000 (equivalent to approximately HK\$33,810,000) to a specific corporate borrower at an interest rate of 8.6% per annum. Shanghai Pudong Development Bank acted as the trustee of the entrusted loan for a trustee fee of 0.1% per month. This entrusted loan matured in August 2017.

As at 31 December 2016, Suncom Logistics had two entrusted loan agreements with China Fortune Securities Co. Ltd. ("China Fortune") and China Minsheng Banking Corp., Ltd. Shanghai Branch ("Minsheng Bank"). Pursuant to these agreements, Suncom Logistics entrusted an aggregated amount of RMB40,000,000 (equivalent to approximately HK\$45,080,000) to a specific corporate borrower at an interest rate of 9.25% per annum. China Fortune acted as a manager to manage the entrusted loan for a management fee of 1.2% per annum and Minsheng Bank acted as the trustee of the entrusted loan for a trustee fee of 0.05% per month. These entrusted loans matured in April 2017.

The sale proceeds exceed the carrying amount of the interest in Xian Helicopter and, accordingly, no impairment loss had been recognised. The remaining consideration has been fully settled during the year ended 31 December 2017 and the disposal has been completed with gain on disposal of an associate of HK\$8,736,000 recognised in current year.

(ii) During the year ended 31 December 2015, the Group incorporated 上海視馬 with registered capital of RMB20,000,000. Initial capital injection of RMB4,000,000 was made by the Group upon incorporation. As at 31 December 2017, the Group and other investors had capital commitment of RMB4,000,000 (equivalent to HK\$4,820,000) (2016: RMB4,000,000 (equivalent to HK\$4,508,000)) and RMB 12,000,000 (equivalent to HK\$14,460,000) (2016: RMB12,000,000 (equivalent to HK\$13,524,000)). #### 35. RETIREMENT BENEFITS SCHEMES

# The Group operates a MPF Scheme under rules and regulations of Mandatory Provident Fund Schemes Ordinance for all its employees in Hong Kong. All the employees of the Group in Hong Kong are required to join the MPF Scheme. Contributions are made based on a percentage of the employees' salaries and are charged to consolidated statement of profit or loss as they become payable in accordance with the rules of the MPF Scheme. The assets of the MPF Scheme are held separately from those of the Group in an independently administered fund. The Group's employer contributions vest fully with the employees when contributed into the MPF Scheme. No forfeited contribution is available to reduce the contribution payable in the future years as at 31 December 2017 and 2016.

The Group's subsidiaries in the PRC, in compliance with the applicable regulations of the PRC, participate in a statemanaged retirement benefits scheme operated by the local government. The subsidiaries are required to contribute a specific percentage of their payroll costs to the retirement benefits scheme. The only obligation of the Group with respect to the retirement benefits scheme is to make the specified contributions.

During the year, the total amounts of HK\$49,467,000 (2016: HK\$62,197,000) contributed by the Group to the schemes and cost charged to the consolidated statement of profit or loss represents contribution payable to the schemes by the Group at rates specified in the rules of the schemes.

# 35. 退休福利計劃

年內,本集團向計劃供款總額49,467,000港元 (二零一六年:62,197,000港元),而於綜合損益表扣除之成本,代表本集團根據計劃規則按指定比率向計劃應付之供款數額。

- (iv) The acceptance of an option, if accepted, must be made within 5 business days from the date of grant. No consideration is required to be paid by the grantee for the grant of options.
- (v) The exercise price of an option must be the highest of:
  - the closing price of the share on the grant date;
  - the average closing price of the share for the 5 trading days immediately preceding the grant; and
  - the nominal value of the share.

- During the year ended 31 December 2015, the Group disposed of its 60% equity interest in 上海鼎 希物聯網科技有限公司 Shanghai Dingxi Internet of Things Technology Limited ("Shanghai Dingxi") at a total consideration of RMB4,000,000 (equivalent to approximately HK\$5,000,000) to the noncontrolling shareholder ("Purchaser") of Shanghai Dixi ("Disposal"). The consideration was to be satisfied by cash, of which (i) the first instalment of RMB1,200,000 to be settled at the date of the completion of the Disposal: (ii) the second instalment of RMB600.000 to be settled on the 90th day of the date of the completion of the Disposal; and (iii) the final instalment of RMB2,200,000 to be settled at the third anniversary date of the date of completion of the Disposal. The settlement date of final instalment of RMB2.200.000 could be delayed to the sixth anniversary date of the date of completion of the Disposal at the discretion of the Purchaser. Fair value of the consideration receivable is estimated by using discounted cash flow method with imputed interest rate of 7.345% per annum at initial recognition and subsequently measured at amortised cost. As at 31 December 2017, the unsettled consideration of RMB2,038,000 (equivalent to approximately HK\$2,456,000) (2016:RMB2,038,000 (equivalent to approximately HK\$2,297,000)) was recorded as consideration receivable in the consolidated statement of financial position.



The management reviews the capital structure by considering the cost of capital and the risks associated with each class of capital. In view of this, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debt or the redemption of existing debt. The Group's overall strategy remains unchanged throughout the year.

## Financial risk management objectives and policies

The Group's major financial instruments include available-for-sale investment, trade and notes receivables and payables, other receivables and payables, accruals, entrusted loan receivables, amounts due from/to non-controlling shareholders of subsidiaries and an associate, consideration receivable, pledged bank deposits, bank balances, bank borrowings and other liabilities. Details of these financial instruments are disclosed in the respective notes. The risks associated with these financial instruments and the policies on how to mitigate these risks are set out below. Management manages and monitors these exposures to ensure appropriate measures are implemented on a timely and effective manner.

### Currency risk

Several subsidiaries of the Group have foreign currency sales and purchases, which expose the Group to foreign currency risk. Approximately 17% (2016: 25%) of the Group's sales are denominated in currencies other than the functional currency of the group entity making the sale, whilst almost 60% (2016: 60%) of costs are denominated in the group entity's functional currency.

In order to minimise the credit risk, the management of the Group has delegated a team responsible for determination of credit limits, credit approvals and other monitoring procedures to ensure that follow-up action is taken to recover overdue debts. In addition, the Group reviews the recoverable amount of each individual debt at the end of each reporting period to ensure that adequate impairment losses are made for irrecoverable amounts. In respect of credit risks arising from amounts due from non-controlling shareholders of subsidiaries and an associate, in the opinion of the Directors, no significant credit risks are expected as there is no default repayment history. In this regard, the Directors consider that the Group's credit risk is significantly reduced.

As at 31 December 2017, the Group invested into one (2016: four) entrusted loan agreements (details are set out in note 21). Under the entrusted loan agreements, the Group provided funding to loan borrowers through licensed asset managers and/or licensed banks, which acted as the assets managers and trustees respectively. The asset managers and the trustee banks do not bear the credit risk of the entrusted loan receivables. Before entering into these agreements, the Group assesses the credit quality of the loan borrowers and defines the terms of the loans. The Group has concentration of risk on the entrusted loan receivables as the loans are made to one (2016: three) entrusted loan borrowers. During the year ended 31 December 2017, the Group received interest income of HK\$7,021,000 (2016: HK\$8,938,000) and recognised as other income. In view of the timely interest repayment, in the opinion of the Directors, the credit risk in respect to the entrusted loan receivables could be monitored.

The Group's bank balances and cash are deposited with banks in Hong Kong and the PRC and the Group has limited the exposure to any single financial institution. In addition, the Group's pledged deposits are also deposited with a bank in the PRC. The credit risk on liquid funds is limited because the counterparties are banks with good reputation.

The Group has concentration of credit risks with exposure limited to certain customers. As at 31 December 2017, five (2016: five) customers amounting to HK\$96,829,000 (2016: HK\$61,792,000) comprised approximately 32% (2016: 26%) of the Group's trade receivables. These customers are within the same mobile phone technology industry in the PRC, Singapore and the United Kingdom. The management closely monitors the subsequent settlement of the customers. In this regard, the Directors consider that the Group's credit risk is significantly reduced.

### Liquidity risk

In the management of the liquidity risk, the Group monitors and maintains a level of cash and cash equivalents deemed adequate by the management to finance the Group's operations and mitigate the effects of fluctuations in cash flows. The management monitors the utilisation of bank borrowings and ensures compliance with loan covenants.

As at 31 December 2017, the carrying amount of bank borrowings amounted to HK\$84,104,000 (2016: HK\$299,991,000). All such bank borrowings included a repayment on demand clause exercisable at any time by the relevant banks and are classified as current liabilities. In accordance with the scheduled repayment dates set out in the loan agreements, the aggregate principal and interest cash outflows amount to HK\$86,057,000 (2016: HK\$300,912,000). However, should the relevant banks exercise their rights to demand immediate repayment, the principal amounts of these bank borrowings amounting to HK\$84,104,000 (2016: HK\$299,991,000) will be repayable on demand. Taking into account the Group's financial position, the Directors do not believe that it is probable that the banks will exercise their discretionary rights to demand immediate repayment.

本集團存在信貸風險集中的情況,風險集中於若干客戶。於二零一七年十二月三十一日,涉及五名(二零一六年:五名)客戶的款項為96,829,000港元(二零一六年:61,792,000港元),佔本集團的應收貿易賬款約32%(二零一六年:26%)。該等客戶位於中國、新加坡及英國同樣從事移動電話技術行業。管理層將密切監察該等客戶往後之結算情況。就此而言,本公司董事認為本集團之信貸風險已大大降低。

### 流動資金風險

管理流動資金風險方面,本集團會監察及維持 現金及現金等值項目於管理層視為充足的水 平,以應付本集團營運所需,並降低現金流量 波動之影響。管理層會監察銀行借貸之運用, 以確保符合貸款契諾。

於二零一七年十二月三十一日,銀行借貸的賬面值達84,104,000港元(二零一六年:299,991,000港元)。所有銀行借貸均載有銀行可於任何時間行使的按要求償還條款,因而分類為流動負債。根據借貸協議中的償還日期,本金及利息現金流出總額為86,057,000港元(二零一六年:300,912,000港元)。然而,如有關銀行行使權利要求即時還款,該等銀行借貸之本金額84,104,000港元(二零一六年:299,991,000港元)將須於要求時償還。考慮到本集團的財務狀況,本公司董事認為銀行不大可能行使其酌情權要求即時償還。

The Directors consider that liquidity risk is limited after considering the future cash flows of the Group in the foreseeable future, including the repayment schedule of bank borrowings as discussed above and the short-term liabilities which are required to be repaid within three months from the end of the reporting period. The Group manages liquidity risk by maintaining adequate reserves by continuously monitoring forecast and actual cash flows and matching the maturity profiles of financial assets and liabilities.

### Interest rate risk

The Group's fair value interest rate risk relates primarily to its entrusted loan receivables.

As at 31 December 2017 and 2016, the Group is exposed to cash flow interest rate risk in relation to variable-rate bank borrowings and bank balances.

The Group currently does not have a cash flow interest rate hedging policy. However, the management closely monitors its exposure to future cash flow risk as a result of change on market interest rate and will consider hedging changes in market interest rates should the need arise. A 100 basis point (2016: 100 basis point) change represents management's assessment of the reasonably possible change in interest rates.

The Group's cash flow interest rate risk is mainly concentrated on the fluctuation of LPR arising from the Group's variable interest rate bank borrowings.

考慮到本集團在可見將來的未來現金流(包括上文所討論的銀行借貸還款時間及需於報告期末後三個月內償還的短期債務)之後,董事認為流動資金風險有限。本集團通過持續監察預期與實際現金流,並將金融資產與負債的到期日相配以維持適當的儲備,從而管理流動資金風險。

### 利率風險

本集團公平值利率風險主要與其應收委託貸款 有關。

於二零一七年及二零一六年十二月三十一日, 本集團就浮息銀行借貸及銀行結餘承受現金流 利率風險。

本集團現時並無現金流利率對沖政策。然而,管理層嚴密監控因市場利率變動而承受之未來現金流風險,並將於需要時考慮對沖市場利率之變動。100個基點(二零一六年:100個基點)之變動乃代表管理層所評估利率可能出現之合理變動。

本集團現金流動利率風險主要集中在本集團浮息銀行借貸產生之貸款基礎利率波動。

### Interest rate risk (continued)

## Sensitivity analysis

The management considers that the Group's exposure to future cash flow risk on variable-rate bank balances as a result of the change of market interest rate is insignificant and thus variable-rate bank balances are not included in the sensitivity analysis.

The sensitivity analysis is prepared assuming the financial instruments outstanding at the end of the reporting period were outstanding for the whole year. If the interest rate of bank borrowings had been 100 basis point (2016: 100 basis point) higher/lower and all other variables were held constant, the Group's post-tax profit for the year ended 31 December 2017 would decrease/increase by HK\$631,000 (2016: HK\$2,016,000). This is mainly attributable to the Group's exposure to interest rates on its variable-rate bank borrowings.

## Price risk

As at 31 December 2017 and 2016, the Group is exposed to other price risk through its listed available-for-sale investment.

## Sensitivity analysis

The sensitivity analysis below has been determined based on the exposure to equity price risk at the end of the reporting period. The sensitivity analysis included the available-for-sale investment carried at fair value. If the price of the respective available-for-sale investment in listed equity securities had been 10% higher/lower, assuming all other variables were held constant, the Group's other comprehensive income (net of tax) for the year ended 31 December 2017 would increase/decrease by HK\$6,019,000 (2016: HK\$14,059,000).

# 利率風險(續)

### 敏感度分析

管理層認為,本集團因市場利率變動向浮息銀 行結餘承受之未來現金流風險不大,因此,敏 感度分析並無包括浮息銀行結餘。

編製敏感度分析乃假設在報告期末尚未償還的金融工具於整年內未償還。如銀行借貸利率上升/下降100基點(二零一六年:100基點)而所有其他變數維持不變,本集團截至二零一七年十二月三十一日止年度的除稅後溢利將會減少/增加631,000港元(二零一六年:2,016,000港元)。這主要是由於本集團浮息銀行借貸的利率風險所致。

於二零一七年及二零一六年十二月三十一日,本集團因其可供出售上市投資而面對其他價格 風險。

## 敏感度分析

下文之敏感度分析乃根據報告期末所面對之股本價格風險釐定。敏感度分析包含按公平值計值的可供出售投資。倘於上市股本證券的相關可供出售投資的價格上升/下降10%,而所有其他變數維持不變,本集團截至二零一七年十二月三十一日止年度的其他全面收益(除稅後)將增加/減少6,019,000港元(二零一六年:14,059,000港元)。

As at 31 December 2017, the Group's available-for-sale investment is listed equity securities outside Hong Kong of HK\$80,253,000 (2016: HK\$187,448,000) which was classified as Level 1 of the fair value hierarchy. The carrying amount of the investments was measured at fair value based on the quoted bid price in an active market.

# Fair value of the Group's financial assets and financial liabilities that are not measured at fair value on a recurring basis

The management of the Group estimates the fair value of its financial assets and financial liabilities measured at amortised cost using the discounted cash flows analysis.

# 44. EVENT AFTER THE PERIOD END DATE 44. 期末日期後事項

On 21 December 2017, the Group entered into a sale and purchase agreement with an independent third party under which the Group has conditionally agreed to dispose of technology and assets in relation to wireless communication modules business at a total consideration of approximately RMB608,000,000 (equivalent to approximately HK\$717,400,000) (the "Disposal"). The Group has received a deposit of approximately RMB51,800,000 (equivalent to approximately HK\$62,419,000). Subsequent to 31 December 2017, the Disposal has been completed and the Group is in the process of assessing the relevant financial impact of the Disposal.
